WHEREAS, in terms of Section 14/15 of the NCTE Act, 1993, Khalisani Basanti Teachers Academy, Plot No. 495, 497, Vill- Khalisani Baganbati, P.O.- Khalisani, Tehsil/Taluka- Singur, Town/City- Chandannagar, Dist- Hooghly, West Bengal -712138 was granted recognition for B.Ed. programme of two year duration with an annual intake of 100 seats (two basic units) from the academic session 2018-2019 vide order No. F.No. ER-252.6.72(Part-4)/ERCAPP3926/B.Ed./2018/56352 dated 03.03.2018 as per NCTE Regulations, 2014.

- AND WHEREAS, the matter was placed in 284th meeting of ERC held on 17th -2. 18th September, 2020 and as per the decision of ERC First SCN was issued to the institution.
- 3. **AND WHEREAS,** the matter was considered by ERC-NCTE in its 303rd(Virtual) meeting held on 24th March 2022 and as per the decision of ERC, Final SCN was issued to the institution on 09.04.2022. The institution has submitted reply/representation of Final Show Cause Notice dated 06.05.2022 received in ERC office on 09.05.2022.
- AND WHEREAS, the matter was considered by ERC in its 336nd meeting of ERC held 4. on 20th December, 2023 and the committee decided the following:

"The original file of the institution alongwith other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time, was considered by ERC and the Committee observed the following:

- The institution has not submitted the faculty list after issuance of SCN dated 09.04.2022.
- The institution has not submitted the original affidavit on Rs. 10/- non-judicial stamp paper by the individual faculty along with their educational qualification certificates.
- The website of the institution is www.kbtacademy.org. However, the institute website is not functioning and the additional information as per clause 7(14), 8(6) 10 (3) of the NCTE Regulation 2014 and Clause 2 (C) of the NCTE Regulations is required to be uploaded.

Hence, Committee decided that the recognition granted to the institution for running B.Ed. Programme be withdrawn under Section 17 (1) of the NCTE Act, 1993 with effect from the end of academic session next following the date of communication of withdrawal order".

- 5. **AND WHEREAS,** in terms of above decision of ERC, the recognition of the institution was withdrawn vide Order dated 30.01.2024.
- 8. **AND WHEREAS**, the institution has preferred appeal before NCTE (HQ) against the Withdrawal Order of ERC dated 30.01.2024 and the Appellate Authority passed order dated 01.04.2024, set aside the withdrawal order of ERC and remanded back the case to ERC with a direction to verify the faculty list submitted in appeal from the concerned Affiliating University and also at is liberty to verify the documents from the concerned competent authortiy. The Appellant institution is directed to forward to the ERC the documents submitted in appeal within 15 days from the receipt of order of the appeal and after receipt of the same the ERC to take further necessary action as per the NCTE Regulation, 2014, guidelines and amendments issued from time to time as per direction given herein above."
- 9. **AND WHEREAS**, the institution has submitted reply/documents dated 10.04.2024 received in ERC office on 18.04.2024. The matter was placed in 343rd meeting of ERC held on 09.05.2024 and the committee decided as under:

"The original file of the institution alongwith Appeal Order No File No. 89-8/E-327363/2024 Appeal/4th Meeting, 2024 APPLERC202414752 dated 01.04.2024, other related documents submitted by the institution, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time, was considered by ERC. The ERC decided the following:-

• The Committee noted that the withdrawal order dated 30.01.2024 has already been set aside by the Appellate Authority and remanded the case back to ERC for consideration, therefore, ERC decided that the recognition granted to the institution for running two years B.Ed. programme with an annual intake of 100 (Two Units) until a fresh withdrawal order is issued by ERC. Order be issued accordingly.

The Committee further decided the following:-

- The faculty list submitted by the institution in compliance of the appeal order be forwarded to the concerned affiliating University for verification."
- 10. NOW THEREFORE, in terms of above decision of ERC, the said recognition granted to the institution viz. Khalisani Basanti Teachers Academy, Plot No, 495, 497, Vill-Khalisani Baganbati, P.O.- Khalisani, Tehsil/Taluka- Singur, Town/City-Chandannagar, Dist- Hooghly, West Bengal -712138 vide order No. F.No. ER-252.6.72(Part-4)/ ERCAPP3926/ B.Ed./2018/56352 dated 03.03.2018 for B.Ed. programme of two year duration with an annual intake of 100 seats (two basic units) is hereby restored until a fresh withdrawal order is issued by ERC.
