<u>ORDER</u>

WHEREAS, Eastern Doors B.Ed. Training College, Alipurduar, Bhatibari, Dist.-Alipurduar, West Bengal - 736121 (Code No.APE00557) was granted recognition for B.Ed. course with an intake of 100 from the academic session 2006-2007 vide ERC order dated 31.10.2006, followed by revised order vide No. 32425 dated 30.05.2015 with an annual intake of 100 from the academic session 2015-2016 as per NCTE Regulations, 2014.

2. **AND WHERAS,** the ERC in its 274^{th} meeting held on $15^{\text{th}} - 16^{\text{th}}$ July, 2019 considered the matter and as decided, recognition granted to B.Ed. course was withdrawn u/s 17(1) vide order no. 61287 dated 20.08.2019 from the academic session 2020-2021 to the institution.

3. **AND WHEREAS,** the institution preferred an appeal to NCTE HQs. against the ERC's order dated 20.08.2019. The Appellate Authority vide order No. 89-346/E-134195 Appeal/31st Mrg.-2019/15th October, 2019 dated 06/11/2019 remanded back the case to the ERC with a direction to consider the documents sent to them by the appellant and take further action as per the NCTE Regulations, 2014.

4. **AND WHEREAS,** the ERC in its 277^{th} meeting held on $19^{th} - 20^{th}$ December, 2019 considered the original file of the institution alongwith other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time and appeal order dated 06.11.2019, and as decided to issue show cause notice under section 17 of the NCTE Act, 1993. Accordingly, show cause notice was issued to the institution on 31.12.2019 on the following grounds:

- a) Original List of members of faculty duly approved by the affiliating university need to be submitted.
- b) FDRs in original along with form 'A' need to be submitted.

5. **AND WHEREAS**, institution submitted reply vide letter dated 18.01.2020 & 04.03.2020 and received in this office on 20.01.2020 & 11.03.2020. The ERC in its 282^{nd} meeting held on $8^{th} - 9^{th}$ July, 2020 and as decided to issue final show cause notice under section 17 of the NCTE, Act, 1993. Accordingly, a final show cause notice was issued to the institution on 24.07.2020 on the following grounds:

a) The institution has submitted original FDRs of Rs. 5 lakh and Rs. 3 lakh only. Rest amount of Rs. 4 lakh FDR in joint mode as per NCTE Regulation, 2014 to be submitted.
