WHEREAS, Raiganj B.Ed. College, P.O. Karnajora, Dist. Uttar Dinajpur, West Bengal-733130 (APE00588) was granted recognition for B.Ed. course with an annual intake of 100 vide ERC's order dated 14.07.2007. Revised recognition order issued on 26.05.2015 with an annual intake of 100 for two basic units from the academic session 2015-2016 as per NCTE Regulation, 2014, followed by corrigendum issued vide no. 33643 dated 09.07.2015 with a one basic unit of 50 (Fifty) students from the academic session 2015-2016.

2. **AND WHEREAS**, the ERC in its 278th meeting held on $16^{th} - 18^{th}$ January, 2020 considered the matter and decided to withdraw recognition to B.Ed. course u/s 17(1) of NCTE Act 1993 from the academic ses sion 2020-2021. Accordingly, withdrawal order was issued vide F.No.ER-278.49/APE00588/B.Ed./2020/62265 dated 05.02.2020 to the institution.

3. **AND WHEREAS**, the institution preferred an appeal to NCTE HQs. against the ERC's order dated 15.09.2020. The Appellate Authority vide order No.89-59/E-155220/2020 Appeal/12th Mtg.-2020/24th July, 2020/93048 dated 15.09.2020 decided that appellant institution is required to submit to ERC within 15 days of the issue of appeal order, Copies of (i) Lease deed and (ii) Building Completion Certificate.

4. **AND WHEREAS,** the institution has submitted representation vide letter dated 20.09.2020 received on 25.09.2020. The ERC in its 286^{th} meeting held on $25^{\text{th}} - 26^{\text{th}}$ November, 2020 considered the matter and as decided, Show Cause Notice was issued on 09.12.2020 to the institution.

5. **AND WHEREAS,** the institution submitted reply vide letters dated 23.12.2020 received on 28.12.2020. The original file of the institution along with other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time, were carefully considered by ERC in its 289th meeting held on 15th February, 2021 and the committee decided as under:-

"Restoration of recognition order of B.Ed. course with an annual intake of 50 (one unit) be issued.

6. NOW, THEREFORE, recognition withdrawn vide order no. F F.No.ER-278.49/APE00588/B.Ed./2020/62265 dated 05.02.2020 to the institution viz. Raiganj B.Ed. College, P.O. Karnajora, Dist. Uttar Dinajpur, West Bengal-733130 (Code No. APE00588) for B.Ed. Course is hereby restored recognition with an annual intake of 50 (one unit).
