WHEREAS, Bijoy Krishna Girls College, 5/3, Mahatma Gandhi Road, Howrah, West Bengal-700001 (Code No. APE00029) was granted recognition for B.Ed. course with an annual intake of 100 vide ERC order dated 12.04.2002, followed by revised order vide No. 32354 dated 29.05.2015 with an annual intake of 100 (two basic units) from the academic session 2015-2016 as per NCTE Regulations, 2014.

AND WHEREAS, the ERC in its 274th meeting held on 15th – 16th July, 2019 considered 2. the matter and as decided, recognition granted to B.Ed. course was withdrawn u/s 17(1) of NCTE Act. 1993 from the academic session 2020-2021 vide order No. ER-274.14.87/APE00029/B.Ed./2019/61298 dated 20.08.2019.

3. **AND WHEREAS,** the institution preferred an appeal to NCTE HQs. against the ERC order dated 20.08.2019. The Appellate Authority vide order No.89-84/E-157346/2020/Appeal/13th Mtg.-2020/27th July, 2020/93132 dated 15.09.2020 decided to remand back the case to ERC for revisiting the matter keeping in view that appellant institution its prepared for a reduced intake of 50 seats.(one unit).

4. **AND WHEREAS**, the institution submitted representation dated 22.09.2020 received on 28.09.2020. The ERC in its 286^{th} meeting held on 25^{th} - 26^{th} November, 2020 considered the matter and as decided, show cause notice u/s 17 of NCTE Act, 1993 was issued to the institution dated 09.12.2020 on the following grounds:

- (i) The institution is conducting two basic units of B.Ed. Course and has requested vide letter dt. 22.09.2020 to reduce the existing intake from 100 to 50.
- (ii) Hence, the institution is required to submit a copy of latest faculty list of qualified staff appointed by the institution, duly approved by the competent authority of the affiliating body for one unit (50 intake) to be submitted.

5. **AND WHEREAS**, the institution submitted reply dated 21.12.2020 & 18.01.2021 in response to show cause notice, received on 28.12.2020 & 21.01.2021. The original file alongwith other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time and reply in response to show cause notice and request of the institution for reducing the intake from 100 to 50, were carefully considered by ERC and the Committee decided as under:-

As per request made by the institution, restoration of recognition order for B.Ed. course with an annual intake of 50 (one unit) be issued.
