**ORDER**

**WHEREAS**, in terms of Section 14/15 of the NCTE Act, 1993, the recognition was granted to **Dhupguri College of Education, Vill- Rey Para, PO- Dhupguri, Dist-Jalpaiguri, West Bengal-735210** for conducting B.Ed. programme of one year duration with an annual intake of 100 student (Two Basic Unit) from the academic session 2012-2013 vide order No. ERC/7-140.4.15/NCTE/B.Ed./2012/13874 dated 31.08.2012, followed by Revised Recognition for B.Ed. programme of two year duration with an annual intake of 100 students (Two Basic Unit) from the academic session 2015-2016 vide order No. F.No.ERC/NCTE/APE01148/B.Ed.(Revised Order)/2015/32373 dated 29.05.2015 as per NCTE Regulations, 2014.

2. **AND WHEREAS**, the ERC in its 274<sup>th</sup> meeting held on 15<sup>th</sup> – July, 2019 considered that 1st Show Cause Notice u/s 17(1) was issued on 14.12.208, followed by the Final Show Cause Notice dated 21.05.2019 and the recognition of the institution was withdrawn vide Order No. F.No.ER-274.14.19/APE01148/B.Ed./2019/61304 dated 20.08.2019.

3. **AND WHEREAS**, the matter of the institution was considered by ERC in its various meetings.

4. **AND WHEREAS**, as per the decision of the 284<sup>th</sup> meeting held on 17<sup>th</sup>-18<sup>th</sup> September 2020, First SCN was issued to the institution on 13.11.2020 on certain grounds.

5. **AND WHEREAS**, as per the decision of ERC in its 290<sup>th</sup>(Part-I) meeting held on 03<sup>rd</sup> March 2021, Final SCN was issued to the institution.

6. **AND WHEREAS**, the replies dated 03.04.2021 and 06.05.2021 were considered by ERC in its 293<sup>rd</sup> meeting held on 09<sup>th</sup> June 2021 and as per the decision of ERC, clarification letter was issued to the institution.

7. **AND WHEREAS**, the original file of the institution alongwith other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time, was considered by ERC in its 328<sup>th</sup> (virtual) meeting held on 12<sup>th</sup> June, 2023 and the Committee observed that:

- *The reply submitted by the institution with reference to letter dated 11.06.2021 was considered by the ERC and the Committee noted that the institution is still deficient of the following grounds:*
  - *The institution has not submitted the faculty list in prescribed format as per NCTE Regulations, 2014.*
  - *The institution has not appointed the Principal.*
  - *The institution has appointed 09 faculty only for an annual intake of 02 units (100 students) against the requirement of 1 + 15 faculty which is grossly inadequate as per NCTE Regulations, 2014.*

*Hence, Committee decided that the recognition granted to the institution for running B.Ed. Programme be withdrawn under Section 17 (1) of the NCTE Act, 1993 with effect from the end of academic session next following the date of communication of withdrawal order.*

Accordingly, Withdrawal Order dated 26.06.2023 was issued to the institution.

8. **AND WHEREAS**, in terms of above decision of ERC, the recognition of the institution was withdrawn vide Order dated 26.06.2023.

9. **AND WHEREAS**, the institution has preferred appeal before NCTE (HQ) against the Withdrawal Order of ERC dated 26.06.2023 and the Appellate Authority passed order dated 27.02.2024, set aside the withdrawal order of ERC and remanded back the case to ERC with a direction to verify the faculty list submitted in appeal from the concerned Affiliating University and at is liberty to verify other documents from the concerned competent authority. The Appellant institution is directed to forward to the ERC the documents submitted in appeal within 15 days from the receipt of order of the Appeal and after receipt of the same the ERC to take further necessary action as per the NCTE Regulation, 2014, guidelines and amendments issued from time to time in terms of direction given herein above.

10. **AND WHEREAS**, the institution has submitted documents dated 08.03.2024 received in ERC office on 21.03.2024. The matter was placed in 343<sup>rd</sup> meeting of ERC held on 09.05.2024 and the committee decided as under:

*"The original file of the institution alongwith Appeal Order No. File no.89-211/E-321149/2023 Appeal/3<sup>rd</sup> Meeting, 2024 APPLERC202314704 dated 27.02.2024, other related documents submitted by the institution, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time, was considered by ERC. The ERC decided the following :-*

- The Committee noted that the withdrawal order dated 26.06.2023 has already been set aside by the Appellate Authority and remanded the case back to ERC for consideration, therefore, ERC decided that the recognition granted to the institution for running two years B.Ed. programme with an annual intake of 100 (Two Units) until a fresh withdrawal order is issued by ERC. Order be issued accordingly.*

*The Committee further decided the following :-*

- The faculty list submitted by the institution in compliance of the appeal order be forwarded to the concerned affiliating University for verification."*

11. **NOW THEREFORE**, in terms of above decision of ERC, the said recognition granted to the institution viz. **Dhupguri College of Education, Vill- Rey Para, PO- Dhupguri, Dist-Jalpaiguri, West Bengal-735210** vide Order No. ERC/7-140.4.15/NCTE/B.Ed./2012/13874 dated 31.08.2012, followed by Revised Recognition for B.Ed. programme of two year duration with an annual intake of 100 students (Two Basic Unit) from the academic session 2015-2016 vide order No. F.No.ERC/NCTE/APE01148/B.Ed.(Revised Order)/2015/32373 dated 29.05.2015 is hereby restored until a fresh withdrawal order is issued by ERC.
