RECOGNITION RESTORATION ORDER

WHEREAS, in terms of Section 14/15 of the NCTE Act, 1993, the recognition was granted to **Don Bosco College of Teacher Education, Tura, West Garo Hills, Meghalaya, Pin Code-794002** recognition for B.Ed. course of one year duration with an intake of 100 vide ERC Order No. ERC/7-40(ER-40.4.1)/2003/3415 dated 11/12.12.2003, followed by revised recognition order for B.Ed. course of two years duration with an intake of 100 students (two basic units) from the academic session 2015-2016 vide order No.F.ERC/NCTE/ERCAPE00244/B.Ed.(Revised Order)/2015/31829 dated 22.05.2015.

- 2. **AND WHEREAS**, as per decision taken by ERC in its 272nd meeting held on May, 30-31 & June, 01.2019, the Recognition granted to the institution was withdrawn by ERC vide order No.F.No.ERC/272.14.165/(ME-S/N-2/2003)/B.Ed/2019/60734 dated 14.06.2019.
- 3. AND WHEREAS, the institution had filed an appeal before the Council (NCTE) under section 18 of NCTE Act, 1993 against the withdrawal order dated 14.06.2019. The Appellant Authority was passed order dated 04.10.2021 and remanded back the case to ERC for re-consideration.
- **4. AND WHEREAS**, in compliance of Appeal order dated 04.10.2021, the case was considered by ERC in its 300th meeting and as per decision of ERC, Show Cause Notice dated 10.01.2022 was issued to the institution on the certain deficiencies. The reply of Show Cause Notice submitted by the institution on 03.02.2022 was considered by ERC in its 302nd Meeting and final Show Cause Notice was issued on 08.03.2022 to the institution.
- 5. AND WHEREAS, The reply of final Show Cause Notice submitted by the institution was considered by ERC in its 306thMeeting held on 12th& 13th July, 2022 and committee decided that the recognition for B.Ed. course with an annual intake of 50 seats (one unit) be restored.

6. NOW THEREFORE, in terms of above decision of ERC, the recognition granted to the institution viz. Don Bosco College of Teacher Education, Tura, West Garo Hills, Meghalaya, Pin Code-794002 vide order No.F.ERC/NCTE/ERCAPE00244/B.Ed.(Revised Order)/2015/31829 dated 22.05.2015 for B.Ed. course with annual intake of 50 seats (one unit) is hereby restored.
