**ORDER**

Whereas, Nalini Devi Womens' College of Teacher Education, Unit- III, Kharvela Nagar, Bhubaneswar, Odisha- 769010 (Code No. OR-S/E-5/99) was granted recognition for conducting M.Ed. course of one year duration with an intake of 24 students from the academic session 2000-2001 vide order no. F.7-13/2000-ERC/845 dt. 06.04.2000.

2. And whereas, after the promulgation of the NCTE Regulations, 2014 a Revised Recognition Order (RRO) no. F. ER-189.12.1.4/M.Ed.(Revised Order)/2015/32665 dt. 31.05.2015 was issued for conducting M.Ed. course of two years duration with an annual intake of 50 students from the academic session 2015-2016 subject to fulfilment of the conditions in respect of enhancement of additional built up area, additional infrastructure, additional fund, additional staff, maintenance & updation of the web-site of institution etc and to submit the compliance to the ERC.


3. And whereas, a public notice was uploaded on the ERC's website on 30.01.2018, wherein 138 TEIs have not furnished their compliance reports in respect of conditions mentioned in the Revised Recognition Order issued on or before 31<sup>st</sup> May, 2015 to these institutions after the promulgation of the NCTE Regulations, 2014. The ERC in its 254<sup>th</sup> meeting held on 16<sup>th</sup> – 17<sup>th</sup> April, 2018 considered the matter and decided to issue Show Cause Notice and same was issued on 20.04.2018 to the institution on the following grounds:-

- a. Approved faculty list (current) by the concerned affiliating body along with requisite documents.
- b. Approved building plan by the concerned competent Govt. Engineer/Authority.
- c. Approved building completion certificate by the concerned competent Govt. Engineer/Authority.
- d. FDRs towards Endowment fund and Reserve fund after conversion into joint operation mode as prescribed in the NCTE Regulations, 2014.
- e. Confirmation on website updates of the institutions with all details along with affidavit.

4. And whereas, the institution submitted reply vide letter dt. 27.05.2019, received in ERC, NCTE on 29.05.2019. The ERC in its 274<sup>th</sup> meeting held on 15<sup>th</sup> – 16<sup>th</sup> July, 2019 considered the matter and decided to issue final Show Cause Notice and same was issued on 22.08.2019 to the institution on the following ground:-

- (i) Building completion certificate is not signed by Govt. Engineer.
- (ii) Building plan is not submitted.
- (iii) Principal (I/c) mentioned in the faculty list is not accepted.

5. **And whereas**, the institution submitted reply vide letter dt. 13.02.2020, received in ERC, NCTE on 14.02.2020. The ERC in its 280<sup>th</sup> meeting held on 29<sup>th</sup> February & 1<sup>st</sup> March, 2020 considered the original file of the institution alongwith other related documents in light of the NCTE Act, 1993, Regulations and Guidelines issued by the NCTE from time to time and observed as under:-

*The institution has fulfilled all criteria as per NCTE Regulations, 2014 in compliance to final show cause notice issued on 22.08.2019. Hence, continuation of Revised Recognition Order (RRO) be issued.*

7. **And whereas**, the ERC in its 283<sup>rd</sup> meeting held on 24<sup>th</sup> & 25<sup>th</sup> August, 2020 reviewed the matter and decided as under:-


- (i) *The institution has submitted 1+8 teaching faculty against the requirement of 10 for running one unit of M.Ed. course as per Appendix-5 of Regulation-2014/Norms & Standards.*
- (ii) *Total built up area mentioned in the Building Plan (BP) is 789.84 Sq. Mts., which is not sufficient to run one unit of M.Ed. course.*

**Hence, M.Ed. course is withdrawn under section 17(1) of NCTE Act, 1993 from the next academic session 2021-22.**

8. **Now therefore**, the recognition granted to the institution viz. Nalini Devi Womens' College of Teacher Education, Unit- III, Kharvela Nagar, Bhubaneswar, Odisha- 769010 (Code No. OR-S/E-5/99) for conducting M.Ed. Course of two year duration with an annual intake of 50 students **is hereby withdrawn under section 17(1) of the NCTE Act, 1993 from the academic session 2021-2022.**

9. **Further**, if the institution is not satisfied by the order, they can prefer an appeal under section 18 of the NCTE Act, 1993 through "Online mode" available on NCTE's website [www.ncte.gov.in](http://www.ncte.gov.in) within 60 days from the date of the issue of the order.


