**ORDER**

WHEREAS, Model B.P.Ed. College, Beguntary, P.O. – Kharia, Vill – College Para, Dist. – Jalpaiguri, West Bengal – 735101 (APE00622) was granted recognition for conducting B.P.Ed. course with an intake of 50 vide ERC Order No. 102092 dated 28/02/2008 for the session 2008-2009, followed by revised order vide No.32381 dated 29/05/2015 with an annual intake of 50 to 100 from the academic session 2015-2016 as per NCTE Regulations, 2014.

2. AND WHEREAS, the ERC in its 274<sup>th</sup> meeting held on 15<sup>th</sup> – 16<sup>th</sup> July, 2019, considered the matter and as decided to issue Show Cause Notice u/s 17(1) was issued on 26/08/2019 to the institution on the following grounds:-


- (i) Approved faculty list by the concerned affiliating body along with requisite documents.
- (ii) Approved building plan by the competent Govt. Engineer/Authority.
- (iii) Approved building completion certificate by the competent Govt. Engineer/Authority.
- (iv) FDRs towards Endowment fund and Reserve fund after conversion into joint operation mode as prescribed in the NCTE Regulations, 2014.
- (v) Confirmation on website updates of the institutions with all details along with affidavit.
- (vi) Fire safety certificate issued from the competent Govt. Authority.

3. AND WHEREAS, the ERC in its 280<sup>th</sup> meeting held on 29<sup>th</sup> Feb & 1<sup>st</sup> March, 2020, for non Compliance of SCN dtd.26/08/2019 and as decided to issue the final show cause notice dtd.03/03/2020.

4. AND WHEREAS, the ERC in its 283<sup>rd</sup> meeting held on 24<sup>th</sup> – 25<sup>th</sup> August, considered the matter along with the reply received from the institution on 08/05/2020 in response to Show Cause Notice dated 03/03/2020 and decided as under :-

- (i) There is a mismatch between faculty list submitted by the institution and details of the same uploaded in the \_ institutional website.
- (ii) Building Plan (BP) is not approved by the competent Govt. Engineer.
- (iii) There is a mismatch of floor-wise and total built up area mentioned in Building Plan (BP) and Building Completion Certificate (BCC).
- (iv) FDRs of Rs. 5 Lakh & 7 Lakh is not in joint mode.

Hence, B.P.Ed. course is withdrawn under section 17(1) of NCTE Act, 1993 from the next academic session 2021-22.






