ORDER

WHEREAS, Shree Ramakrishna Mission B.T. College, 27, Gandhi Road, Darjeeling, West Bengal -734101 (WB-S/E-5/1996 & APE00729) was granted recognition for B.Ed. course with an intake of 60 from the academic session 2001-2002 vide ERC order dated 15/06/2001. The intake has been enhanced from 60 to 100 from the academic session 2014-2015 vide order dated 03/03/2014, followed by revised recognition order issued on 26/05/2015 with an intake of 100 (two basic units) from the academic session 2015-2016 as per NCTE Regulation, 2014.

2. **AND WHEREAS**, the ERC in its 274th meeting held on 15th – 16th July, 2019 considered the matter and as decided, recognition granted to B.Ed. course was withdrawn u/s 17(1) vide order no. 61283 dated 20.08.2019 from the academic session 2020-2021 to the institution.

3. **AND WHEREAS**, the institution preferred an appeal to NCTE HQs. against the ERC's order dated 20.08.2019. The Appellate Authority vide order No.89-341/E-133599/2019 Appeal/30th Mtg.-2019/14th October, 2019/83409 dated 25/10/2019 rejected the appeal and the order of the ERC is confirmed.


4. **AND WHEREAS**, the institution filed Writ Petition No. 13389/2019 & Appl. 54330/2019 dated 10.02.2020 before the Hon'ble High Court of Delhi against the decision taken by Appellate Authority. In compliance of Court Order, the ERC in its 281st meeting held on 21st March, 2020 considered the matter and as decided, Show Cause Notice u/s 17(1) was issued on 24/04/2020 to the institution.

5. **AND WHEREAS**, the institution has submitted reply vide letter dated 20/06/2020 received in this office on 30/06/2020. The ERC in its 282nd meeting held on 8th – 9th July, 2020 considered the matter and as decided, Final Show Cause Notice was issued on 24/07/2020 to the institution on the following grounds:

- (i) Blue print of consolidated Building Plan (BP) mentioning the details of Plot No./khasra No., total land area, total built up area etc. duly approved by the Govt. Engineer to be submitted.
- (ii) Faculty list duly signed by the concerned affiliating body in the prescribed proforma to be submitted.
- (iii) Certified copy of Fire Safety Certificate duly signed by the Govt. competent Authority to be submitted.

6. **AND WHEREAS**, the institution submitted reply vide letter dated 30/07/2020 received in this office on 12/08/2020. The original file of the institution along with other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time, were carefully considered by ERC in its 283rd meeting held on 24th & 25th August, 2020 and the committee decided as under:-

“Restoration of Recognition Order for B.Ed. course to be issued for one unit (50 intake) only”.




