Withdrawal Order

Whereas, Hindi Teacher's Training Institute, Block No.-29, Old Secretariat, Dist.-Cuttack, Odisha-753001 (Code No. APE00550) was granted recognition for conducting B.H.Ed. (Bachelor of Hindi Education) course of one year duration with an intake of 100 vide ERC order no. ERC/7-78.6(I).7/2007/69201 dated 06.08.2007, followed by revised order vide no. 32738 dated 31.05.2015 from the academic session 2015-2016 as per NCTE Regulations, 2014 subject to fulfilment of the conditions in respect of enhancement of additional built up area, additional infrastructure, additional fund, additional staff, maintain and update website and to comply the same to the ERC.

- 2. And whereas, the ERC in its 254^{th} meeting held on $16^{th} 17^{th}$ April, 2018 considered the matter and as decided, a show cause notice u/s 17(1) was issued on 20.04.2018 to the institution on the following grounds:
 - a. Approved faculty list (current) by the concerned affiliating body along with requisite documents.
 - b. Approved building plan by the concerned competent Govt. Engineer/Authority.
 - c. Approved building completion certificate by the concerned competent Govt. Engineer/Authority.
 - d. FDRs towards Endowment fund and Reserve fund after conversion into joint operation mode as prescribed in the NCTE Regulations, 2014.
 - e. Confirmation on website updates of the institutions with all details along with affidavit.
- 3. And whereas, the institution has submitted reply vide letter no. 196 dt. 30.05.2018 in response to show cause notice. The ERC in its 263^{rd} Meeting held on $15^{th} 16^{th}$ November, 2018 considered the matter and decided to issue IInd Show Cause Notice and same was issued on 26.11.2018 to the institution on the following grounds:-
 - (i) Faculty list submitted is not signed by the concerned affiliating body and not in sufficient numbers i.e. not as per Norms. Required faculties (1+15) qualified as per NCTE Regulations, 2014 need to be appointed and list of fresh faculty duly approved by the affiliating body is to be submitted.
 - (ii) Building plan and building completion certificate duly approved by Govt. Engineer are not submitted.

(iii)No confirmation of website.

4. And whereas, the institution has submitted reply letter dt. 10.01.2019, 02.05.2019 and 21.05.2019, received in ERC, NCTE on 14.01.2019, 02.05.2019 and 30.05.2019. The ERC in its 274^{th} meeting held on $15^{th}-16^{th}$ July, 2019 considered the original file of the institution alongwith other related documents in light of the NCTE Act, 1993, Regulations and Guidelines issued by the NCTE from time to time and observed as under:-

"1st show cause notice u/s 17(1) issued on 20.04.2018, followed by final show cause notice dated 26.11.2018 and the institution is still deficient on the following grounds:-

- (i) Faculty list is not as per NCTE Regulations, 2014.
- (ii) Faculty list comprises 1+7 as against the requirement of 1+15 as per NCTE Regulations, 2014.

Recognition granted to B.H.Ed. course is withdrawn under section 17(1) of NCTE Act, 1993 from the academic session 2020-2021."

- 5. Now therefore, the recognition granted, u/s 14 of the NCTE Act, 1993, to the Hindi Teacher's Training Institute, Block No.-29, Old Secretariate, Dist.-Cuttack, Odisha-753001 (Code No. APE00550) for conducting B.H.Ed. Course of two year duration with an annual intake of 100 is hereby withdrawn under section 17(1) of the NCTE Act, 1993 from the academic session 2020-2021.
- 6. Further, if the institution is not satisfied by the order, they can prefer an appeal Under Section 18 of the NCTE Act in the "Online mode" available on NCTE's website www.ncte.gov.in within 60 days from the date of the issue of the order.
