ORDER

WHEREAS, in terms of Section 14/15 of the NCTE Act, 1993, Anugrah Narayan College, Plot No-42, Street No- Boring Road, Vill-SK Puri, PO-Patliputra, Tehsil/Taluka-Patna, Sadar, Town/City-Patna, Dist-Patna, Bihar-800013 was granted recognition for conducting B.Ed. programme of two year duration with an annual of session 2015-2016 vide 50 from the academic intake seats F.No.187.6.2/ERCAPP1446/B.Ed./2015/31666 dated 15.05.2015 as per NCTE Regulations, 2014.

AND WHEREAS, the decision taken by the General Body of the council (NCTE) in its meeting decided to issue public notice dated 09.09.2024 with the direction to all recognised Teacher Education Institution to submit PAR for the academic session 2021-2022 & 2022-2023 through online mode on NCTE Portal. The last date to submit the PAR was 10.11.2024 which was further extended to 10.12.2024 and subsequently to 31.12.2024 by the NCTE vide public notice dated 07.11.2024 & 10.12.2024 respectively.

In addition to above public notices, multiple attempts through press release, regular reminder e-mails and video messages of the chairperson and member secretary of NCTE in this regard were uploaded across all major social media platforms for all the recognised Teacher Education Institution for timely Submission of the PAR.

Above all direction issued vide above referred public notice. The institution has not submitted PAR for the academic session 2022-2023.

AND WHEREAS, the aforesaid matter was considered by ERC in its 362nd meeting held on 25th March, 2025 and the committee decided as under:

"The matter was considered by ERC in its meeting and as per decision taken by the Regional committee to submit written representation before withdrawal of the above recognition/permission under section 17 of NCTE act, 1993 on the ground of Non-Submission of the PAR for the academic session 2022-23 was issued by the ERC to the institution through online mode on 28.03.2025, a copy of the same was also sent through speed post."

AND WHEREAS, the aforesaid matter was placed before ERC in its 366th meeting held on 13th May, 2025 decided as under:

The matter was considered by ERC in its meeting and committee decided that the recognition granted to Anugrah Narayna College as referred above be withdrawn academic session 2025-2026. The Institution is not entitled to admit student in the above referred programmes from the academic session 2025-2026. The Student admitted up to the academic session 2024-2025 shall complete their programme.

- The institution has not submitted any reply to the show cause notice.
- Accordingly, Withdrawal Order dated 15.05.2025 was issued to the institution 5.
- AND WHEREAS, the institution preferred appeal before NCTE (HQ) against the Withdrawal Order of ERC dated 15.05.2025 and the Appellate Authority, NCTE passed an order vide Order No. File No. 89-258/E-371270/2025 Appeal/9th Meeting, 2025 APPLERC202515191/E-87842 dated 19.09.2025, decided to remand back the case to ERC.
- AND WHEREAS, the institution has submitted reply/documents dated 23.09.2025. The matter was placed in 378th Emergent Meeting of ERC held on 26.09.2025 and the committee decided as under:

"Decision of ERC

The original file of the institution along with other related documents, NCTE Act, 1993, NCTE Rules, Regulations, Appeal Order dated 19.09.2025 passed by the NCTE-HQ, SOP, guidelines issued from time to time were placed before the Eastern Regional Committee and the Committee observed the following: -

- The recognition was granted to the institution for B.Ed programe of two years duration with an intake of 50 students (one basic unit) from the academic session 2025-2026.
- In pursuance of the decision taken by the general body of the council (NCTE), public notice dated 09.09.2024 was issued by the NCTE with the direction to all recognised Teacher Education Institution to submit PAR for the academic session 2021-2022 & 2022-2023 through online mode on NCTE Portal. The last date to submit the PAR was 10.11.2024 which was further extended to 10.12.2024 and subsequently to 31.12.2024 by the NCTE vide public notice dated 07.11.2024 & 10.12.2024 respectively.
- In addition to above public notices, multiple attempts through press release, regular reminder e-mails and video messages of the chairperson and member secretary of NCTE in this regard were uploaded across all major social media platforms for all the recognised Teacher Education Institution for timely Submission of the PAR.
- Despite all directions issued vide above referred public notice, the institution has not submitted PAR for the academic session 2022-2023.
- The matter was considered by ERC in its 362nd meeting held on 25th March, 2025 and decision taken by the Regional committee to submit written representation before withdrawal of the above recognition/permission under section 17 of NCTE act, 1993 on the ground of Non-Submission of the PAR for the academic session 2022-23 was communicated by the ERC to the institution through online mode on 28.03.2025, a copy of the same was also sent through speed post.
- All the recognized teacher education institution were also informed vide public notice dated 02.04.2025 that show cause notice under section 17(1) of the NCTE Act, 1993 is being issued to the institution that have not filled up the PAR by the Regional Committee concerned on the address email of the institution available with the office of the regional committee concerned with the direction to submit their reply within 15 days through online mode only from the date of issue of SCN on the NCTE web portal.
- The matter was considered by ERC in its 366th meeting held on 13th May, 2025 and committee decided that the recognition granted to Anugrah Narayna College as referred above be withdrawn from the academic session 2025-2026. The Institution is not entitled to admit student in the above referred programmes from the academic session 2025-2026. The Student admitted upto the academic session 2024-2025 shall complete their programme.
- Accordingly, Withdrawal Order was issued to the institution vide Order No. File No. NCTE/2025/ERC/PAR/ORDER/ERCAPP1446/70737-70743 dated 15.05.2025
- The institution thereafter filed an appeal against the Order No. File No. NCTE/2025/ERC/PAR/ORDER/ERCAPP1446/70737-70743 dated 15.05.2025 before NCTE Appellate Authority and the NCTE Appellate Authority decided as under:-

After perusal of the appeal report, documents on record, Appeal committee of the council concluded to set aside the impugned order dated 15.05.2025 and remand back the case to Eastern Regional Committee for fresh Consideration in accordance with the directions specified hereinabove. The appellant institution is further directed to forward to the regional committee, within fifteen (15) days of receipt of this order, the documents submitted along with the appeal, whereupon the regional committee shall take further necessary action strictly in accordance with law and in light of the directions contained herein.

The institution has submitted the reply via email dated 23.09.2025 and 25.09.2025 respectively.

In view of the above, the Committee decided that the recognition of the institution be restored in the light of decision of Appellate Authority. Concerned affiliating body be informed accordingly.

Further, the institution is directed to resubmit PAR upon reopening of the PAR Portal in accordance with prescribed standard operating Procedure, and the Regional Committee shall thereafter take a reasoned decision in conformity with the provision of the NCTE Act, 1993, the NCTE Regulation, 2014 and guidelines issued from time to time.

NOW THEREFORE, in terms of above decision of ERC, the recognition granted to the institution viz. Anugrah Narayan College, Plot No-42, Street No- Boring Road, Vill-SK Puri, PO-Patliputra, Tehsil/Taluka-Bihar-800013 Town/City-Patna, Dist-Patna, F.No.187.6.2/ERCAPP1446/B.Ed./2015/31666 dated 15.05.2015 for B.Ed. programme of two year duration with an annual intake of 50 seats (one basic unit) is hereby restored. Further, the institution is directed to resubmit PAR upon reopening of the PAR Portal in accordance with prescribed standard operating Procedure.
