WITHDRAWAL ORDER

WHEREAS, in terms of Section 14(1) of the NCTE Act, 1993 Sahid Khudiram Education Trust, Plot No.1006, 1553, 1555, Street No.-NH6, Vill.-DakshinMechogram, P.O.-Uttar Mechogram, Tehsil/Taluka-Tamluk, Town/City-Panskura, Dist.-Midnapore, West Bengal – 721139 had applied for grant of recognition to Sahid Khudiram College of Education, Plot No.1006, 1553, 1555, Street No.-NH6, Vill.-DakshinMechogram, P.O.-Uttar Mechogram, Tehsil/Taluka-Tamluk, Town/City-Panskura, Dist.-Midnapore, West Bengal – 721139 was granted recognition for conducting D.El.Ed. Course vide order dated 02.05.2017 for 100 (Two basic units) from the academic session 2017-2018.

2. AND WHEREAS a complaint letter dated 05.05.2017 received against the institution. The matter was placed before the ERC in its 282^{nd} Meeting held on $8^{th} - 9^{th}$ July, 2020 and ERC decided to issued Show Cause notice under section 17 of the NCTE Act, 1993.

3. **AND WHEREAS**, as per above decision of ERC, Show cause notice was issued to the applicant Institution on dated 10th August, 2020. The institution has submitted reply dated 01.09.2020 received on 08.09.2020. The original file of the Institution alongwith other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time, reply of the institution were carefully considered by ERC in its 303rd (Virtual) meeting held on 24th March, 2022 and the Committee decided to issue the Final Show Cause notice to the institution.

4. AND WHEREAS, as per above decision of ERC, Final Show Cause Notice issued to the institution on dated 05.04.2022, the institution has submitted reply of Final Show Cause Notice which was received on 30.04.2022 & 21.05.2022. The original file of the Institution alongwith other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time, reply of the institution were carefully considered by ERC in its 306th (Virtual) meeting held on $12^{th} - 13^{th}$, 2022 and the Committee made following observations:

As per the decision of ERC taken in its 282ndmeeting, the first Show Cause Notice dated 10.08.2020 was issued to the institution under section 17 of NCTE Act, 1993, the reply of SCN was considered by ERC in its 303rd meeting and as per the decision of ERC, the final Show Cause Notice under section 17 of NCTE Act, 1993 was issued to the institution on 05.04.2022. The institution has submitted reply dated 30.04.2022, 21.05.2022 which were carefully considered by ERC and found the institution deficient on the following grounds:

1. The Institution has submitted Land Documents wherein the total land area is only 3078.41 Sqmts for two units of B.Ed. programme and two units of D.El.Ed programme. As per NCTE Regulations, the land area of 3500 sqmts. is required for 2 unit B.Ed Course and 2 unit D.El.Ed course. Hence, the institution does not fulfil the land requirement as per NCTE Regulations, 2014 as amended from time to time.

Hence, ERC decided that the recognition for D.El.Ed. Course be withdrawn under Section 17 (1) of the NCTE Act, 1993 with effect from the end of academic session next following the date of communication of withdrawal order on the above grounds.

NOW THEREFORE, In terms of above decision of ERC, the recognition granted to Sahid Khudiram College of Education, Plot No.1006, 1553, 1555, Street No.-NH6, Vill.-DakshinMechogram, P.O.-Uttar Mechogram, Tehsil/Taluka-Tamluk, Town/City-Panskura, Dist.-Midnapore, West Bengal – 721139 for D.El.Ed. Course vide order No.ER/7/212.7 .16/ERCAPP3950 /D.El.Ed/ 2016/46443 dated 02.05.2016 is hereby withdrawn under Section 17(1) of NCTE Act, 1993 with effect from the end of academic session next following the date of communication of this withdrawal order.

6. Further, if the institution is not satisfied by the order, they can prefer an appeal under Section of the NCTE Act, 1993 in the "Online mode" available on NCTE's website www.ncte.gov.in within 60 days from the date of the issue of the order.
