WITHDRAWAL ORDER

WHEREAS, in terms of Section 14(1) of the NCTE Act, 1993, Goaltore Educational Training Institute, Vill-Subalbandi, P.O.-Jirapara, Tehsil/Taluka-Goaltore, District-Midnapore, West Bengal-721121 was granted recognition under Clause 7(11) of NCTE (Recognition Norms & Procedure) Regulation, 2009 for conducting D.El.Ed. course of two year duration with an annual intake of 50 (one basic unit) from the academic session 2014-2015 vide order dated 03.03.2014.

- 2. AND WHEREAS, a complaint letter dated 28.08.2015 & 25.01.2017 received against the institution. The matter was placed before the ERC in its 282nd Meeting held on 8th -9th July, 2020 and decided to issued Show Cause Notice under 17 of the NCTE Act, 1993.
- 4. **AND WHEREAS**, as per above decision of ERC show cause notice was issued to the applicant institution on 13th August, 2020. The institution has not submitted reply of Show Cause Notice, the original file of the institution along with other related documents, in the light of NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time, were carefully considered by ERC in its 303rd (Virtual) meeting held on 24th March, 2022, and the Committee decided to issue Final Show Cause Notice to the institution.
- **4. AND WHEREAS**, as per above decision of ERC, Final Show Cause Notice issued to the institution on 21.04.2022, the institution has not submitted reply of Final Show Cause Notice. The original file of the institution alongwith other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time and reply in response to show cause notice were carefully considered by ERC in its 306^{th} (Virtual) meeting held on $12^{th} 13^{th}$, 2022 and the Committee made following observations:

As per the decision of ERC taken in its 282nd meeting, the first Show Cause Notice dated 13.08.2020 was issued to the institution under section 17 of NCTE Act, 1993, the matter was again considered by ERC in its 303rdmeeting and as per the decision taken—by ERC, the final show cause notice dated 13.08.2020 was issued to the institution under section 17 of NCTE Act, 1993. The reply submitted by the inafter that final SCN was issued to the institution on 21.04. 2022. The institution has not submitted reply of show cause notices issued to the institution on dated 13.08.2020 and 21.04.2022. The mater was carefully considered by ERC and observed as follows:

- 1. The institution has not submitted any reply in response of Final SCN dated 21.04.2022.
- 2. The SCN issued to the institution retuned by the post office to the ERC office on 05/05/2022 with the remarks that this institution totally closed since last two years which clearly establishes that the institution is not in existence on the address given by the institution in its application.

Hence, ERC decided that the recognition for B.Ed. Course be withdrawn under Section 17 (1) of the NCTE Act, 1993 with effect from the end of academic session next following the date of communication of withdrawal order on the above grounds.

- 5. NOW THEREFORE, in terms of above decision of ERC, the recognition granted to Goaltore Educational Training Institute, Vill Subalbandi, P.O.-Jirapara, Tehsil/Taluka-Goaltore, District- Midnapore, West Bengal-721121 for D.El.Ed. Course vide order No. ER -/7-170.6. 9/NCTE/D.El.Ed/2014/ 24326 dated 03.03.2014 is hereby withdrawn under Section 17(1) of NCTE Act, 1993 with effect from the end of academic session next following the date of communication of this withdrawal order.
- 6. Further, if the institution is not satisfied by the order, they can prefer an appeal under Section of the NCTE Act, 1993 in the "Online mode" available on NCTE's website www.ncte.gov.in within 60 days from the date of the issue of the order.
