WITHDRAWAL ORDER

WHEREAS, in terms of Section 14/15 of the NCTE Act, 1993, Provadevi B.Ed. College, Plot No.-8602, Vill.-Barnia, P.O.-Barnia, Tehsil/Taluka-Tehatta, Town/City-Tehatta, Dist.-Nadia, West Bengal-741156 was granted recognition for B.Ed. Course with an intake of 100 vide ERC Order dated 03.03.2013, followed by revised order for B.Ed. course of two years duration with an intake of 100 students from the academic session 2015-2016 vide Order dated 31.05.2015.

- 2. **AND WHEREAS**, the ERC in its 274th meeting held on 15th 16th July, 2019 decided that recognition granted to B.Ed. course be withdrawn under Section 17(1) of NCTE Act, 1993 from the academic session 2020-2021. As per decision of Committee, withdrawal order was issued on 20.08.2019.
- 3. **AND WHEREAS**, the institution had preferred an appeal U/s 18 of NCTE Act, 1993 before the council (NCTE) against the ERC's withdrawal order dated 20.08.2019. The Appellate Authority vide order No.89-118/E-181329/2021 Appeal/17th Meeting, 2021 APPLERC202113977 dated 19.08.2021 remanded back the case to ERC with a direction to forward, the documents to ERC submitted in appeal, within 15 days of receipt of orders on the appeal. As per direction of the Appelate Authority the institution was submitted document on 21.08.2021 which is received in the office of ERC on 15.09.2021.
- 4. **AND WHEREAS**, in compliance of Appeal order dated 19.08.2021, the ERC in its 302^{nd} (Virtual) Meeting held on 28^{th} February & 01^{st} March, 2022 considered the submission of institution and the original file of the Institution alongwith other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time, and appeal order 19.08.2021 and decided to issued Show Cause Notice under 17 of the NCTE Act, 1993.
- 5. AND WHEREAS as per above decision taken by ERC, SCN was issued to the institution on 08.03.2022. The institution has submitted reply in response to the Show Cause Notice on dated 27.05.2022. The ERC in its 306th (Virtual) meeting held on 12th 13th, 2022 and considered the original file of the institution alongwith other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time and reply in response to Show Cause Notice and the Committee made following observations:-

First SCN was issued to the institution on 08.03.2022. The institution has submitted reply dated 21.04.2022, and found still deficient on the following grounds.

1. The requisite certificate of NET /Ph.D. are not submitted by the institution in respect of faculty to verify their qualification with reference to NCTE Norms prescribed in the NCTE Regulations, 2014.

Hence, ERC decided that the recognition for B.Ed. Course be withdrawn under Section 17 (1) of the NCTE Act, 1993 with effect from the end of academic session next following the date of communication of withdrawal order on the above grounds.

- 6. NOW THEREFORE, recognition granted to Provadevi B.Ed. College, Plot No.-8602, Vill.-Barnia, P.O.-Barnia, Tehsil / Taluka-Tehatta, Town/City-Tehatta, Dist.-Nadia, West Bengal-741156 for B.Ed. Course vide order No. F. ERC/7-170.6.81/NCTE/B.Ed/2014/24402 dated 03.03.2014 is hereby withdrawn in terms of Section 17(1) of NCTE Act, 1993 with effect from the end of academic session next following the date of communication of this withdrawal order.
- 7. Further, if the institution is not satisfied by the order, they can prefer an appeal under Section 18 of the NCTE Act, 1993 in the "Online mode" available on NCTE's website www.ncte.gov.in within 60 days from the date of the issue of the order.
