Sub: Compliance order passed by Hon'ble High Court in W.P.(C) 1002/2022 & CM Appl. 3230/2020 filed by Krishnapur Teacher Training Institute Vs National Council for Teacher Education and Anothers.

Sir/Madam,

In terms of decision taken by ERC, the the recognition granted to Krishnapur Teachers Training Institute, Vill.-Krishnapur, PO.-Krishnapur, Dist.-Birbhum, West Bengal-731237 for B.Ed course was withdrawn by ERC vide order No. ER-274.14.79/APE001189/2019/61272 dated 19.08.2019.

2. *The institution had filed W.P (C) No. 1002/2020 & CM APPL 3230/2020 before the Hon'ble High Court of Delhi against withdrawal order dated 19.08.2019 issued by ERC and the Hon'ble High Court passed an Order dated 27.01.2020 and 22.08.2022 with the following direction:*

".....2. This court, by way of an interim order dated 27th January, 2020, stayed the operation of the impugned order.

3. Petitioner- institute has filed this application seeking a direction upon NCTE to communicate the recognised status of Petitioner- Institute to the Affiliating University and to update website.

4. In view of the above –noted interim order operating in favour of Petitioner- Institute, the withdrawal order of NCTE is at present in abeyance, and thus, the relief sought in merited.

5. The application is allowed and NCTE is directed to communicate the Petitioner's status as a recognized institution for the academic year 2022-2023, and thereafter, until disposal of the writ petition, to the Department of Higher Education, Government of West Bengal as well as the affiliating University within a period of one week from today....."

3. *In compliance of the above Orders dated 27.01.2020 and 22.08.2022 passed by the Hon'ble High Court, the case was considered by ERC in its 308th meeting held on 02nd Sep, 2022 and the Committee decided the following:-*



- *The withdrawal Order dated 19.08.2019 issued by ERC in respect of this institution is hereby stayed.*

The Status of the institution as a recognized institution for the academic year 2022-2023 and thereafter, until disposal of the writ petition be communicated to the institution, State Government and the affiliating body concerned.

3. In compliance of above Hon'ble High Court Order dated 27.01.2020 & 22.08.2022 and decision of ERC the withdrawal Order dated 19.08.2019 issued by ERC in respect of this institution is hereby stayed. It is clarified that status the said institution is a recognized institution for the academic year 2022-2023.
