**CORRIGENDUM**

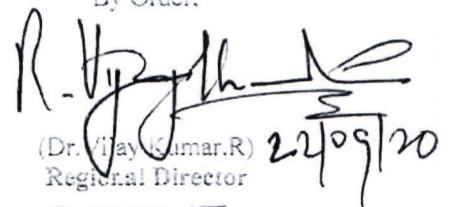

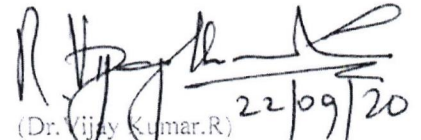
