ORDER

WHEREAS, S.K. Roy Memorial Institute of Education, Po.- Katlicherra, Lala, Dist.-Hailakandi, Assam -788161 (Code No. APE00850) was granted recognition for B.Ed. course with an intake of 100 from the academic session 2009-2010 vide ERC Order No. 2884 dated 08.01.2010, followed by revised order vide No. 31848 dated 22.05.2015 with an annual intake of 50 from the academic session 2015-2016 as per NCTE Regulations, 2014.

- 2. AND WHEREAS, the ERC in its 279^{th} held on $14^{th} 16^{th}$ February, 2020 considered the matter and as decided, Final Show Cause Notice u/s 17(1) was issued on 26.02.2020 to the institution on the following grounds:
 - (i) Approved faculty list (current) by the concerned affiliating body along with requisite documents.
 - (ii) Approved building plan by the concerned competent Govt. Engineer/Authority.
 - (iii) Approved building completion certificate by the convened competent Govt. Engineer/Authority.
 - (iv) FDRs towards Endowment fund and Reserve fund after conversion into joint operation mode as prescribed in the NCTE Regulations, 2014.
 - (v) Confirmation on website updates of the institutions with all details along with affidavit.
 - (vi) Certified copy of registered land document to be submitted.
 - (vii) Certified copy of Fire Safety Certificate duly signed by the Govt. competent authority to be submitted.
- 3. **AND WHEREAS**, the ERC in its 282nd meeting held on 8th & 9th July, 2020 considered the matter along with the reply dated 04.03.2020 & 13.03.2020 received in this office on 12.03.2020 & 08.05.2020 submitted by the institution in response to Final Show Cause Notice and observed as under:
 - a) List of teaching faculty list is not in the NCTE prescribed proforma duly approved by the concerned affiliating body.
 - b) Blue print of Building Plan (BP) mentioning the details of Plot No./khasra No., total land area, total built up area etc. duly approved by the Govt. Engineer is not submitted
 - c) Validity of photocopy FDRs of Rs.5 lakh and Rs.3 lakh has been expired on 24.07.2019. Renewed FDRs of Rs.5 lakh and Rs.7 lakh have not submitted as per NCTE Regulation, 2014.
 - d) Requisite information of the institutional website has not updated as per clause 7(14)(i) of NCTE Regulation, 2014.

- 4. NOW THEREFORE, recognition granted to the institution viz. S.K. Roy Memorial Institute of Education, Po.- Katlicherra, Lala, Dist.-Hailakandi, Assam -788161 (Code No. APE00850) for B.Ed. Course is hereby withdrawn under section 17(1) of NCTE Act, 1993 with effect from the academic session 2021-2022.
- 5. **FURTHER,** if the institution is not satisfied by the order, they can prefer an appeal Under Section 18 of the NCTE Act in the "Online mode" available on NCTE's website www.ncte-india.org within 60 days from the date of the issue of the order.
