## Order

In terms of Section 14(1) of the NCTE Act, 1993 Hills College of Management and Information Technology, 1<sup>st</sup> floor, Takar Complex, Naharlagun, Dist. Papumpare, Arunachal Pradesh—791 110 had submitted an application to the Eastern Regional Committee of NCTE for grant of recognition for starting B.Ed. Course of one year duration from the academic session 2005-2006 with an annual intake of 100 (one hundred) students.

- 2. On scrutiny of the application submitted by the institution, the documents attached therewith, the inputs received from the visiting team, the Committee has noted the following:
  - i. The institution has acquired the land for setting up the teacher education institution.
  - ii. The institution is not functioning from its own building.
  - iii. The institution building is shared for running another course(s).
  - iv. The institution has not selected Principal and only short listed 08 (eight) faculty members for final selection for the said course and the list of faculty members has not been approved by the competent authority of the affiliating university.
- 3. The Eastern Regional Committee in its 64<sup>th</sup> Meeting considered its decision taken in 60<sup>th</sup> ERC Meeting advising the institution to change its name from "College of Management and Information Technology" to College of Teacher Education or Institute of Teacher Education or similar names and directed to issue the recognition order on receipt of their reply. The institution vide their letter dated 14.02.2006 intimated to change the name of Hills College of Management and Information Technology to 'Hills College of Teacher Education'.
- 4. Now, therefore, in exercise of the powers vested under Section 14(3) (a) of the NCTE Act, 1993, the Regional Committee hereby grants recognition to Hills College of Teacher Education, 1<sup>st</sup> floor, Takar Complex, Naharlagun, Dist. Papumpare, Arunachal Pradesh 791 110 for B.Ed. course of one year duration from the academic session 2006-2007 with an annual intake of 100 (hundred) students subject to the compliance of the following conditions before the commencement of the course:
  - The institution will ensure that Principal and at least 07 (seven) faculty members duly qualified as per NCTE norms are in position for an intake of 100 students before the commencement of the course and a report to this effect shall be sent the Eastern Regional Committee within one month of the commencement of the course.
  - b. The institution shall submit a list of teaching staff duly countersigned by the competent authority of the University within one month of the commencement of the course.
  - c. The institution shall pay salary to the teaching staff as prescribed by State Govt./ UGC.
  - d. The institution shall within one month of the receipt of recognition order, convert the Endowment Fund account into a Joint Account in the form of FDR for a period of not less than 60 months (five years) in a Nationalised Bank to be operated along with an official of the Regional Committee.

- e. The institution shall create a Reserve Fund for an amount equal to three months salary of the teachers and staff within one month from the date of issue of this order and maintain in the form of FDR in favour of the management of the institution for a period of not less than sixty months (five years) in a Nationalised Bank
  - f. The institution shall adhere to all the other regulations and guidelines as framed by NCTE from time to time.
- 4. Further, the recognition is subject to fulfillment of all such other requirements as may be prescribed by other regulatory bodies like UGC, the State Government etc.
- 5. The institution shall submit to the Regional Committee a Performance Appraisal Report at the end of each academic year along with a copy of the approval of the affiliating university to the appointment of faculty members, and the statement of annual accounts duly audited by a Chartered Accountant.
- 6. If the institution contravenes any of the above conditions or any of the provisions of the NCTE Act, Rules, Regulations and Orders made or issued there under, the Regional Committee may withdraw the recognition under the provisions of Section 17(1) of the NCTE Act.
