ORDER

WHEREAS, Hills College of Teacher Education, 1st Floor, Takar Complex, Naharlagun, Dist.- Papumpare, Arunachal Pradesh-791110 (Code No. APE00531) was granted recognition for **B.Ed.** course with an intake of 100 from the academic session 2006-2007 vide ERC Order No. 441-447 dated 18.02.2006, followed by revised order vide No.31612 dated 09.05.2015 from the academic session 2015-2016 as per NCTE Regulations, 2014 subject to fulfilment of the conditions in respect of enhancement of additional built up area, additional infrastructure, additional fund, additional staff, maintain and update website and to comply the same to the ERC.

2. **AND WHEREAS,** the ERC in its 272nd meeting held on 31st January, 2019 considered the matter and as decided, Show Cause Notice u/s 17(1) was issued on 10.02.2019 to the institution on the following grounds:

3. **AND WHEREAS,** the ERC in its 274th Meeting held on 15th – 16th July, 2019 considered the matter and no reply has been received from the institution in response to Show Cause Notice dated 17.06.2019 and observed as under.

➤ 1st show cause notice u/s 17(1) issued on 20.04.2018. Final show cause notice issued dated 18.05.2019 on the following grounds:

(i) Faculty list not submitted.

No reply received and the stipulated time period has already been over.

Recognition granted to **B.Ed. course** is **withdrawn** under section 17(1) of NCTE Act, 1993 from the academic session 2020-2021.

4. **NOW THEREFORE,** recognition granted to the institution viz. **Hills College of Teacher Education, 1st Floor, Takar Complex, Naharlagun, Dist.- Papumpare, Arunachal Pradesh-791110 (Code No.APE00531)** for **B.Ed. Course** is hereby **withdrawn** under section 17(1) of NCTE Act, 1993 from the academic session 2020-2021.
