- 3. **AND WHEREAS**, the ERC in its 274<sup>th</sup> Meeting held on 15<sup>th</sup> 16<sup>th</sup> July, 2019 considered the matter and no reply has been received from the institution in response to Show Cause Notice dated 17.06.2019 and observed as under.
  - > 1st show cause notice u/s 17(1) issued on 20.04.2018. Final show cause notice issued dated 18.05.2019 on the following grounds:
    - (i) Faculty list not submitted.

No reply received and the stipulated time period has already been over.

Recognition granted to **B.Ed. course** is **withdrawn** under section 17(1) of NCTE Act, 1993 from the academic session 2020-2021.

4. NOW THEREFORE, recognition granted to the institution viz. Hills College of Teacher Education, 1st Floor, Takar Complex, Naharlagun, Dist.- Papumpare, Arunachal Pradesh-791110 (Code No.APE00531) for B.Ed. Course is hereby withdrawn under section 17(1) of NCTE Act, 1993 from the academic session 2020-2021.
