#### ORDER

WHEREAS, Daying Ering College of Teacher Education, Diking, Pasighat, Arunachal Pradesh-791102 [Formerly: Doying Gumin College, PO.— Pasighat, East Siang, Arunachal Pradesh — 791102] (Code No.APE00564) was granted recognition for B.Ed. course with an intake of 100 from the academic session 2008-2009 vide ERC Order No.12797 dated 30.08.2008, followed by revised order vide No.31617 dated 09.05.2015 from the academic session 2015-2016 as per NCTE Regulations, 2014 subject to fulfilment of the conditions in respect of enhancement of additional built up area, additional infrastructure, additional fund, additional staff, maintain and update website and to comply the same to the ERC.

- 2. **AND WHEREAS,** the ERC in its  $254^{th}$  meeting held on  $16^{th}-17^{th}$  April, 2018 considered the matter and Show Cause Notice u/s 17(1) was issued on 20.04.2018 to the institution on the following grounds:
  - a. Approved faculty list (current) by the concerned affiliating body along with a requisite documents.
  - b. Approved building plan by the concerned competent Govt. Engineer/Authority.
  - c. Approved building completion certificate\_by the concerned competent Govt. Engineer/Authority.
  - d. FDRs towards Endowment fund and Reserve fund after conversion into joint operation mode as prescribed in the NCTE Regulations, 2014.
  - e. Confirmation on website updates of the institutions with all details along with affidavit.
- 3. **AND WHEREAS**, reply dated 23.04.2018 from the institution in response to Show Cause Notice was considered by ERC in its 264<sup>th</sup> meeting held on 05<sup>th</sup> 06<sup>th</sup> December, 2018 and second Show Cause Notice u/s 17(1) was issued on 17.12.2018 to the institution on the following grounds:
  - (i) Qualification of Principal viz. Mr. Dhrubajyoti Taid is only M.A.(History) but not Ph.D. as per NCTE Regulations, 2014.
  - (ii) Blue print of building plan mentioning the details of plot number, khasra number, total land area and total built up area duly approved by Govt. Engineer is to be submitted.
  - (iii) Building completion certificate approved by Govt. Engineer in the NCTE prescribed proforma is not submitted.

- 4. AND WHEREAS, reply received dated 31.12.2018 from the institution in response to Show Cause Notice was considered by ERC in its 265th meeting held on 08th 09th January, 2019 considered the matter and third Show Cause Notice u/s 17(1) was issued on 17.01.2019 to the institution on the following grounds:
  - (i) Qualification of principal is not as per NCTE Regulations, 2014. Of the case
  - (ii) Photocopy of building plan in piecemeal and small fonts. The institution is required to submit blue print of building plan duly approved by Govt. Engineer.
  - (iii) Total built up mentioned in the building completion certificate is 484.50 Sq. Mts., which is less as per NCTE Regulations, 2014.
- 5. AND WHEREAS, the ERC in its 270th Meeting held on 25th 26th March, 2019 considered the matter along with the reply dated 15.02.2019 submitted by the institution in response to Show Cause Notice and observed as under:
  - (i) Show Cause Notices u/s 17(1) were issued on 20.04.2018, 17.12.2018
  - (ii) Principal is not qualified as per NCTE Regulations, 2014 For a not qualified as per NCTE Re
    - authority of the affiliating body not indicated.

      (iv) Total built up area in the building completion certificate mentioned as 150 built in certif

In view of the above, the Committee decided as under: The Committee is of the opinion that recognition granted to B.Ed. course of the application bearing Code No.APE00800 is withdrawn under section 17(1) of NCTE Act, 1993 with effect from the academic session 2019-2020.

- 6. AND WHEERAS, the order of withdrawal was not issued to the institution and the matter was re-considered by ERC in its 271st meeting held on 24-25 April, 2019 under the Agenda Item No.271.1.23 before confirmation of proceedings of 270th ERC meeting held on 25-26 March, 2019.
- 7. AND WHEREAS, the ERC in its 271st meeting held on 24-25 April, 2019 analyzed the matter and observed that sufficient opportunity has been given to the institution issuing Show Cause Notice thrice for fulfillment of deficiency, however the institution failed to comply the same.

In view of the above, the Committee decided as under:

The above decision of ERC remains unchanged. Accordingly, order of withdrawal of recognition be issued to the institution and all concerned.
