ORDER

WHEREAS in terms of Section 14(1) of the NCTE Act, 1993 the District Institute of Education and Training, Pasighat, East Siang District, Arunachal Pradesh-791102 has submitted an application to the Eastern Regional Committee of NCTE for grant of recognition for starting **D.E.Ed. (E.T.E) Course of two years** duration.

2. AND WHEREAS on scrutiny of the application submitted by the institution, the documents attached therewith the affidavit and the input received from the visiting team in the form of report and videography, the Committee is satisfied that the institution / society fulfills the requirements under the provisions of NCTE Act, Rules and relevant Regulations including the Norms and Standards for the **Elementary Teacher Education Programme [D.E.Ed. (E.T.E.)]** such as instructional facilities, infrastructural facilities, library, accommodation, financial resources, laboratory etc. for running the programme and has appointed duly qualified teaching staff as per NCTE norms.

3. NOW, THEREFORE, in exercise of the powers vested under Section 14(3)(a) of the NCTE Act, 1993, the Eastern Regional Committee hereby grants recognition to **District Institute of Education and Training, Pasighat, East Siang District, Arunachal Pradesh-791102** for conducting **D.E.Ed.(E.T.E) Course of two years** duration from the date of issue of order with an annual intake of **50 (fifty)** students. The institution shall ensure the fulfillment of the following:-

- a) The institution will ensure that the teaching faculty members **(1(one) Principal +5 (five) teachers)** duly qualified as per NCTE norms are in position for an intake of **50** students before the commencement of the course and a report to this effect shall be sent to the Eastern Regional Committee before the commencement of the course, and information be put up in the institution website as per NCTE regulation 2005, notified in Gazette of India dated 13th January, 2006.

- b) The institution shall pay salary to the teaching staff as prescribed by State Govt./affiliating body through Account Payee Cheque.
- c) The number of administrative staff shall be maintained as per NCTE norms. The qualifications of technical support staffs shall be maintained as per norms prescribed by NCTE. The qualifications of the administrative staff shall be maintained as per norms prescribed by NCTE.
- d) The institution shall obtain affiliation from the examining body before the commencement of the course.
- e) The institution shall **launch its website** within 90 days of the issue of the order.
- f) The institution shall maintain and update their website as per NCTE regulations.
- g) The intake, eligibility and admission procedure shall be strictly adhered as per NCTE norms.
- h) Performance Appraisal Report shall be submitted by the end of every academic year on the prescribed format.
- i) The institution shall submit affidavit of Rs.100/- on non-judicial stamp paper duly attested by Notary/First Class Magistrate on the prescribed format as per NCTE regulations (**format attached**).
- j) The institution shall adhere to all the other regulations and guidelines as framed by NCTE from time to time.

4. Further, the recognition is subject to fulfillment of all such other requirements as may be prescribed by other regulatory bodies like UGC and the State Government etc, wherever applicable.


5. The institution shall submit to the Eastern Regional Committee a Self Appraisal Report at the end of each academic year along the statement of annual accounts duly audited by a Chartered Accountant.
