### Order

In exercise of the authority vested under NCTE Act, the Eastern Regional Committee after considering the application of **Baihata Chariali B.Ed. College, P.O. Baihata Chariali, Dist. Kamrup – 781 381 (Assam)** for grant of recognition to the B.Ed. course of one year duration, decided to extend one year conditional recognition for the academic year 2000-2001 with intake of 60 subject to removal of the following deficiencies :

- 1.Principal and six full-time qualified teaching staff should be in position by 30.6.2000.
- 2.The teachers should be paid as per UGC/State Govt. scales.
- 3.Multipurpose Lab. with equipment should be developed as per NCTE norms.
4. Books in the library should be as per NCTE norm.
- 5.The institution should function 6 hours in day time as per NCTE norm.
- 6.The students with 45% marks in Graduation/Post Graduation are admitted for the said course.
- 7.Furniture and other equipment should be as per NCTE norm.
8. Curriculum transaction should be as per NCTE norms.
- 9.Supervised Practice Teaching should be conducted as per NCTE norms.
- 10.Hostel for students and staff quarters should be constructed as per NCTE norm.
- 11.Reserve fund and Endowment fund should be maintained as per NCTE norms.

The institution is advised to send a compliance report about removal of the above deficiencies to the Eastern Regional Committee by 31.8.2000.
