ORDER

WHEREAS, College of Teacher Education, Tulsiram Road, Tinsukia, Assam-786125 (Code No. APE00096) was granted recognition for B.Ed. course with an intake of 60 from the academic session 2002-2003 vide ERC's order No.ERC/7-26/2002/2090(7) dated 17.07.2002, followed by revised order from the academic session 2015-2016 with an intake of 50 (one basic unit) vide dated 22.05.2015 as per NCTE Regulations, 2014 subject to fulfilment of the conditions in respect of enhancement of additional built up area, additional infrastructure, additional fund, additional staff, maintain and update website and to comply the same to the ERC.

2. **AND WHEREAS**, the ERC in its 267th meeting held on 10th – 11th February, 2019 considered the matter and Show Cause Notice u/s 17(1) was issued on 21.02.2019 to the institution on the following grounds:

- Approved faculty list (current) by the concerned affiliating body along with requisite documents.
- Approved building plan by the concerned competent Govt. Engineer/Authority.
- Approved building completion certificate by the concerned competent Govt. Engineer/Authority.
- FDRs towards Endowment fund and Reserve fund after conversion into joint operation mode as prescribed in the NCTE Regulations, 2014.
- Confirmation on website updates of the institutions with all details along with affidavit.

3. **AND WHEREAS**, the institution has submitted reply dt. 07.03.2019 in response to show cause notice dt. 21.02.2019 received in this office on 20.03.2019. The ERC in its 271st Meeting held on 24th – 25th April, 2019 considered the matter and final show cause notice u/s 17(1) was issued on 14.05.2019 on the following ground:-

- The institution has not submitted requisite documents in compliance of SCN dated 21.02.2019.

4. **AND WHEREAS**, the institution has submitted reply dt. 11.06.2019 & 03.07.2019 in response to show cause notice received on 01.07.2019 & 12.07.2019. The ERC in its 275th meeting (Part 1) held on 26th July, 2019 after considering the matter and observed that the institution is still deficient on the following grounds:-

- Approved faculty list is not as per NCTE Regulations, 2014 as three teachers are part-time.

5. **NOW THEREFORE**, recognition granted to the institution viz. **College of Teacher Education, Tulsiram Road, Tinsukia, Assam-786125 (Code No. APE00096)** for B.Ed. Course is hereby **withdrawn** under section 17(1) of NCTE Act, 1993 from 2020-2021.

6. **FURTHER**, if the institution is not satisfied by the order, they can prefer an appeal Under Section 18 of the NCTE Act in the "Online mode" available on NCTE's website www.ncte-india.org within 60 days from the date of the issue of the order.
