 - (v) Converted FDRs in joint operation mode is required to be uploaded on institution website.
 - (vi) Teaching faculty and other required documents in PDF form not uploaded & updated on institution website.
- 3. AND WHEREAS, the matter was placed before the committee in its 274^{th} ERC meeting held on 15^{th} 16^{th} July, 2019 for non-compliance of SCN Issued previously on 18.05.2019 and committee took decision as under:
 - ➤ Hence, Recognition granted to **B.Ed. course** is **withdrawn** under section 17(1) of NCTE Act, 1993 from the academic session 2020-2021.
- 4. NOW THEREFORE, recognition granted to the institution viz. KRD College of Education, Chhaygaon, Kamrup, Assam-781124 (Code No. APE00155) for B.Ed. Course is hereby withdrawn under section 17(1) of NCTE Act. 1993 from the academic session 2020-2021.
