ORDER

WHEREAS, Silchar College of Education, Subhas Nagar, Silchar, Cachar, Assam-788004 (Code No. APE00167) was granted recognition for B.Ed. course with an intake of 60 from the academic session 2003-2004 vide ERC order No.1552 dated 11.08.2003, followed by revised order with an intake of 100 (two basic unit) vide No.32591 dated 31.05.2015 from the academic session 2015-2016 as per NCTE Regulations, 2014 subject to fulfilment of the conditions in respect of enhancement of additional built up area, additional infrastructure, additional fund, additional staff, maintain and update website and to comply the same to the ERC.

- 2. **AND WHEREAS**, the ERC in its 272nd meeting held on 30th 31st May & 1st June, 2019 considered the matter and as decided, recognition to B.Ed. Course was withdrawn u/s 17(1) vide order no. 60920 dated 27.06.2019 from the academic session 2019-2020 on the following grounds:-
 - (i) Show Cause Notice u/s 17(1) were issued on 20.04.2018, 26.11.2018 & 22.02.2019.
 - (ii) The submitted faculty list is not as per NCTE Regulations, 2014.
 - (iii) Photocopy of FDRs are not in joint mode with RD, ERC, NCTE.
 - (iv) Photocopy of building plan is not readable for which the total land area, built up area, khata number & khesra number and approving authority could not be ascertained
 - (v) Despite repeated SCN and adequate opportunity for compliance, the said institution has failed to fulfill the Norms as per NCTE Regulations, 2014.
- 3. **AND WHEREAS**, the institution preferred an appeal to the NCTE Hqrs. against the ERC's order dated 27.06.2019. The Appellate Authority vide its Order No.89-316/E-129515/2019 Appeal/29th Mtg.-2019/11th October, 2019/83349 dated 25.10.2019 remanded back the case to ERC with a direction to consider the documents, given in appeal, to be submitted to them by the appellant and take further action as per the NCTE Regulation, 2014. The appellant is directed to forward to the ERC, all the documents submitted in the appeal, with originals thereof, wherever necessary, within 15 days of receipt of order on the appeal.
- 4. **AND WHEREAS**, the institution submitted reply vide letter dated 11.11.2019 received on 20.11.2019. The ERC in its 277^{th} meeting held on $19^{th} 20^{th}$ Dec, 2019 considered the matter and as decided, Show Cause Notice was issued on 26.12.2019 to the institution on the following grounds:
 - (i) Members of faculty list duly approved by the affiliating body as per NCTE Regulations, 20 14 in original needs to be submitted.
 - (ii) Building Plan is not legible. Legible copy of Building Plan duly signed by the competent authority need to be submitted.
