Order

In terms of Section 14(1) of the NCTE Act, 1993 <u>Silchar College of Education</u>, <u>Subhas Nagar</u>, <u>Silchar</u>, <u>Cachar – 788 004</u>, <u>Assam</u> had submitted an application to the Eastern Regional Committee of NCTE for grant of recognition for starting <u>B.Ed.</u> Course of <u>One</u> year duration from the academic session <u>2003-2004</u> with an annual intake of <u>60 (Sixty)</u> students.

- 2. On scrutiny of the application submitted by the institution, the documents attached therewith and the input received from the visiting team, the Committee has noted the following:
 - i) The institution has acquired the land for setting up the teacher education institution.
 - ii) The institution has made arrangements for conducting the course in rented premises.
 - iii) The institution has created an Endowment Fund of Rs. 5.00 lakhs and a Reserve Fund of Rs. 2.79 lakhs (equivalent to three months salary of teaching staff)
 - iv) The institution has appointed the Principal and selected nine regular lecturers for the said course and the list of faculty members has also been approved by the affiliating University.
- 3. Now, therefore, in exercise of the powers vested under Section 14(3) (a) of the NCTE Act, 1993, the Regional Committee hereby grants recognition to <u>Silchar College of Education</u>, <u>Subhas Nagar, Silchar, Cachar 788 004, Assam for B.Ed.</u> Course of <u>one</u> year duration from the academic session <u>2003-2004</u> with an annual intake of <u>60 (Sixty)</u> students subject to fulfillment of the following:
 - a. That the institution will ensure that <u>Principal</u> and at least <u>seven</u> regular faculty members duly approved by the affiliating University are in position for an intake of <u>60</u> students before commencement of the course and a report to this effect shall be sent to the Eastern Regional Committee within one month of commencement of the course.
 - b. The institution shall shift to its own premises within three years from the date of recognition.
 - c. Teachers appointed with M.A. and B.Ed. qualification will have to acquire M.Ed. qualification within five years.
 - d. The institution shall comply with the various other norms and standards prescribed in the NCTE regulations.
- 4. Further, the recognition is subject to fulfillment of all such other requirements as may be prescribed by other regulatory bodies like UGC and the State Government etc.

- 5. The institution shall submit to the Regional Committee a Self-Appraisal Report at the end of each academic year along with a copy of the approval of the affiliating university to the appointment of faculty members, and the statement of annual accounts duly audited by a Chartered Accountant.
- 6. If the institution contravenes any of the above conditions or any of the provisions of the NCTE Act, Rules, Regulations and Orders made or issued thereunder, the Regional Committee may withdraw the recognition under the provisions of Section 17(1) of the NCTE Act.
