ORDER

WHEREAS, Silchar College of Education, Subhas Nagar, Silchar, Cachar, Assam-788004 was granted recognition for B.Ed. course with an intake of 60 from the academic session 2003-2004 vide order dated 11.08.2003, followed by revised order dated 31.05.2015 with an intake of 100 (two basic units) from the academic session 2015-2016 as per NCTE Regulations, 2014 subject to fulfilment of the conditions in respect of enhancement of additional built up area, additional infrastructure, additional fund, additional staff, maintain and update website and to comply the same to the ERC.

2. **AND WHEREAS,** the ERC in its 272nd meeting held on 30th, 31st May & 01st June'2019 considered the matter along with the reply dated 04.04.2019 submitted by the institution in response to Show Cause Notice and observed as under:-

- Show Cause Notice u/s 17(1) were issued on 20.04.2018, 26.11.2018 & 22.02.2019.
- The submitted faculty list is not as per NCTE Regulations, 2014.
- Photocopy of FDRs are not in joint mode with RD, ERC, NCTE.
- Photocopy of building plan is not readable for which the total land area, built up area, khata number & khesra number and approving authority could not be ascertained.
- Despite repeated SCN and adequate opportunity for compliance, the said institution has failed to fulfil the Norms as per NCTE Regulations, 2014.

In view of the above, the Committee decided as under:-

The Committee is of the opinion that recognition granted to B.Ed. course of the application bearing Code No.APE00167 is withdrawn under section 17(1) of NCTE Act, 1993 from the academic session 2019-2020.

3. **AND WHEREAS,** the order of withdrawal was not issued to the institution and the matter was re-considered by ERC in its 273rd (Emergent) meeting held on 14th June'2019 through online mode and observed that in terms of Section 17(1) of NCTE Act, 1993, order withdrawing or refusing recognition passed by the Regional Committee shall come into force only with effect from the end of the academic session next following the date of communication of such order. In the instant cases, all formalities and process of counselling for admission of students have been completed by the affiliating/examining bodies for the next academic session 2019-2020.

In view of the above, the Committee decided as under:-

Recognition to B.Ed. course be withdrawn from the academic session **2020-2021** instead of 2019-2020 in all respect and orders be issued accordingly.
