### Order

In terms of Section 14(1) of the NCTE Act, 1993 Dr. Shyama Prasad Mukherjee College of Education, Assam University Road, Ghugoor, Silchar, Cachar – 788 014, Assam had submitted an application to the Eastern Regional Committee of NCTE for grant of recognition for starting B.Ed. course of one year duration from the academic session 2003-2004 with an annual intake of 100 (one hundred) students.

2. On scrutiny of the application submitted by the institution, the documents attached therewith, the inputs received from the visiting team; the Committee has noted the following:

- i) The institution has acquired the land for setting up the teacher education institution.
- ii) The institution has constructed the building for conducting the course on the above mentioned land.
- iii) The institution has selected the Principal and 07 (seven) faculty members for the said course and the list of faculty members have not been duly approved by the affiliating University.

3. Now, therefore, in exercise of the powers vested under Section 14(3) (a) of the NCTE Act, 1993, the Regional Committee hereby grants recognition to **Dr. Shyama Prasad Mukherjee College of Education, Assam University Road, Ghugoor, Silchar, Cachar – 788 014, Assam** for B.Ed. Course of One year duration from the academic session 2005-2006 with an annual intake of 100 (one hundred ) students subject to fulfillment of the following conditions:

- a. The institution will ensure that Principal and at least 07 (seven) faculty members duly qualified as per NCTE norms are in position for an intake of 100 students before the commencement of the course and a report to this effect shall be sent to the Eastern Regional Committee within one month of commencement of the course.
- b. The institution shall submit a list of teaching staff duly countersigned by the competent authority of the University within one month of the commencement of the course.
- c. The institution shall, within one month of the receipt of recognition order, convert the endowment fund account into a joint account to be operated along with an official of the Eastern Regional Committee.
- d. The institution shall pay salary to the teaching staff as prescribed by State Govt./ UGC.
- e. The institution shall comply with the various other norms and standards prescribed in the NCTE regulations.

4. Further, the recognition is subject to fulfillment of all such other requirements as may be prescribed by other regulatory bodies like UGC, the State Government etc.
5. The institution shall submit to the Regional Committee a Performance Appraisal Report at the end of each academic year along with a copy of the approval of the affiliating body to the appointment of faculty members, and the statement of annual accounts duly audited by a Chartered Accountant.
6. If the institution contravenes any of the above conditions or any of the provisions of the NCTE Act, Rules, Regulations and Orders made or issued thereunder, the Regional Committee may withdraw the recognition under the provisions of Section 17(1) of the NCTE Act.
