ORDER

WHEREAS, Dakshin Guwahati B.Ed. College, Fatasil Ambari, Guwahati, Assam. (APE00214) was granted recognition for B.Ed. course with an intake of 100 from the academic session 2005-2006 vide ERC Order No. 2121 dated 30.06.2005, followed by revised order vide No.31839 dated 22.05.2015 with an intake of 100 from the academic session 2015-2016 as per NCTE Regulations, 2014 subject to fulfilment of the conditions in respect of enhancement of additional built up area, additional infrastructure, additional fund, additional staff, maintain and update website and to comply the same to the ERC.

- 2. **AND WHEREAS**, the ERC in its 274th meeting held on 15th -16th July, 2019 considered the matter and as decided, Show Cause Notice u/s 17(1) was issued on 22.08.2019 to the institution on the following grounds:
 - (i) The total built-up area mentioned in the building completion certificate is 1661.804Sq. Mts. Which is less than 2000Sq.Mts. for running two units (100 intake) of B.Ed. course.
 - (ii) In the faculty list, 06 faculties are in part time on basis, not accepted.
 - AND WHEREAS, the ERC in its 278th Meeting held on 16th 18th January, 2020 considered the matter and reply dated 22.7.2019 & 14.08.2019 from the institution in response to Show Cause Notice dated 22.08.2019 and observed as under.
 - ➤ 1st show cause notice u/s 17(1) issued on 21.02.2019 follow by Final show cause notice issued dated 21.05.2019 and the institution is still deficient on the following ground:-
 - (i) The institution submitted a representation dated 06.08.2019 seeking extension of some more time, which is not permissible as per NCTE Regulation.
 - (ii) Total built up area mentioned in the building completion certificate is 1661.804 Sq. Mts. which is less than 2000 Sq. Mts. for running two units (100 intake) of B.Ed. course.
 - (iii) List of teaching faculty is submitted by the institution in which 6 teaching faculty is on Part-time mode, which is not acceptable as per Appendix-4 of NCTE Regulation, 2014.

Hence, B.Ed. course is withdrawn under section 17(1) of NCTE Act, 1993 from the next academic session 2020-21.

4. NOW THEREFORE, recognition granted to the institution viz. Guwahati B.Ed. College, Fatasil Ambari, Guwahati, Assam. (Code No. APE00214) for B.Ed. Course is hereby withdrawn under section 17(1) of NCTE Act, 1993 from the academic session 2020-2021.
