## Order

In terms of Section 14(1) of the NCTE Act, 1993 Dakshin Guwahati B.Ed. College, Fatasil Ambari, Guwahati, Kamrup, Assam, Pin – 781 025 had submitted an application to the Eastern Regional Committee of NCTE for grant of recognition for starting B.Ed. course of one year duration from the academic session 2003-2004 with an annual intake of 100 (one hundred) students.

- 2. The Committee has constituted a visiting team to visit the institution and the visiting team had since submitted its report.
- 3. On 29.6.2004, the Regional Committee in its 46<sup>th</sup> meeting after considering the report of the visiting team as well as other relevant materials furnished by the institution had opined that it did not fulfill the requirements and issued a notice on 13.7.2004 to the institution under provision to Section 14 (3) (b) of the NCTE Act. 1993 thereby giving an opportunity to the said institution to make a written representation in this behalf.
- 4. The institution has submitted representation dated 27.7.2004 to ERC, NCTE. The said representation of the institution along with visiting team report were duly considered by the Regional Committee in its 47<sup>th</sup> meeting held on 29.7.2004, which came to the conclusion that recognition to the said institution be refused under section 14(3) (b) of the NCTE Act for the following reasons:
  - i. The institution does not have full-time qualified Principal as per the NCTE norms.
  - ii. The teacher at sl. 8 does not have required teaching experience as per NCTE norms.
  - iii. The salary is not paid as prescribed by State Government/ UGC.
- 5. The institution preferred an appeal on 08.10.2004 to the National Council for Teacher Education, New Delhi under Section 18 of the NCTE Act, 1993 against the Order of refusal of recognition No. 2468 dated August 16, 2004.
- 6. After careful consideration of all aspects of the matter and perusal of the documentary evidences the Council was satisfied that the institution had complied with the requirements of NCTE norms, "removed deficiencies existing at the time of inspection which were minor in nature" and came to the conclusion that the Order of the ERC, Bhubaneswar deserves to be quashed and the case of Dakshin Guwahati B.Ed. college, Kamrup, Assam be processed further by the ERC reversing the order appealed against vide its Order No. 89-277/2004 Appeal dated 19.11.2004.
- 7. ERC, NCTE vide its letter No. 3834 dated December 23, 2004 asked the institution to submit the documentary evidence in respect of appointment of teaching staff and payment of salary as prescribed by State Govt./ UGC, which were produced before the appeal Committee of NCTE Hqrs.
- 8. The Eastern Regional Committee in its 57<sup>th</sup> meeting held on 2-3 June 2005 considered the order by the Appeal Committee and noted that the information submitted by the institution before the Appeal Committee was not available before the ERC while refusing recognition.
- 9. The Committee considered the order of the Appeal Committee of the Council reversing ERC order of refusal of recognition and decided that the Daskhin Guwahati B.Ed. College, Fatasil Ambari, Guwahati, Assam, Pin 781 025 may be granted recognition from 2005-2006 session with an intake of 100 students with conditions as required under NCTE norms.

- 10. Now, therefore, in exercise of the powers vested under Section 14(3) (a) of the NCTE Act, 1993, the Regional Committee hereby grants recognition to **Daskhin Guwahati B.Ed. College, Fatasil Ambari, Guwahati, Assam, Pin 781 025** for **B.Ed.** Course of one year duration from the academic session 2005-2006 with an annual intake of 100 (one hundred) students subject to fulfillment of the following:
  - a. The institution will ensure that Principal and at least 07 (seven) faculty members duly qualified as per NCTE norms are in position for an intake of 100 students before the commencement of the course and a report to this effect shall be sent to the Eastern Regional Committee within one month of commencement of the course.
  - b. The institution shall submit a list of teaching staff duly countersigned by the competent authority of the University within one month of the commencement of the course.
  - c. The institution shall, within one month of the receipt of recognition order, convert the endowment fund account into a joint account to be operated along with an official of the Eastern Regional Committee.
  - d. The institution shall pay salary to the teaching staff as prescribed by State Govt./ UGC.
  - e. The institution shall comply with the various other norms and standards prescribed in the NCTE regulations.
- 11. Further, the recognition is subject to fulfillment of all such other requirements as may be prescribed by other regulatory bodies like UGC, the State Government etc.
- 12. The institution shall submit to the Regional Committee a Performance Appraisal Report at the end of each academic year along with a copy of the approval of the affiliating University to the appointment of faculty members, and the statement of annual accounts duly audited by a Chartered Accountant.
- 13. If the institution contravenes any of the above conditions or any of the provisions of the NCTE Act, Rules, Regulations and Orders made or issued thereunder, the Regional Committee may withdraw the recognition under the provisions of Section 17(1) of the NCTE Act.
