**Order**

In exercise of the authority vested under NCTE Act, the Eastern Regional Committee after considering the application of **Asom Sikshak Prasikshan Mahavidyalaya, Lankeswar, Jalukbari, Guwahati - 781 014 (Assam)** for grant of recognition to the B.Ed. course of one year duration, decided to extend one year conditional recognition for the academic year 2000-2001 with intake of 60 subject to removal of the following deficiencies :

1. Principal and six full-time qualified teaching staff should be in position by 30.6.2000 and reported to ERC.
2. The teachers should be paid as per UGC/State Govt. scales.
3. Multipurpose Lab. with equipment should be developed as per NCTE norms.
4. Furniture, equipment and other infrastructure facilities like common-room, sports room, etc. should be developed.
5. Supervised practice teaching should be as per NCTE norms.
6. Books in the library should be increased from 395 to 1500 as per NCTE norm.
7. The institution should function 6 hours in day time as per NCTE norm.
8. The Endowment funds and reserve funds should be maintained as per NCTE norms.
9. The students with 45% marks in Graduation/Post Graduation are admitted in the said course.
10. The institution should obtain affiliation from the university and report to ERC.

The institution is advised to send a compliance report about removal of the above deficiencies to the Eastern Regional Committee by 31.8.2000.
