#### **ORDER**

WHEREAS, Sipajhar B.Ed. College, PO- Sipajhar, Dist- Darrang, Assam - 784145 (APE00314) was granted recognition for B.Ed. course with an intake of 100 from the academic session 2014-2015 vide ERC Order No. 884(1) dated 18.03.2005, followed by revised order vide No. 31773 dated 20.05.2015 from the academic session 2015-2016 as per NCTE Regulations, 2014 subject to fulfilment of the conditions in respect of enhancement of additional built up area, additional infrastructure, additional fund, additional staff, maintain and update website and to comply the same to the ERC.

- 2. AND WHEREAS, the ERC in its  $263^{rd}$  meeting held on  $15^{th}$   $16^{th}$  November, 2018 considered the matter and as decided, Show Cause Notice u/s 17(1) was issued on 28.11.2018 to the institution on the following grounds:
  - (i) Faculty list comprising 10 instead of 16 as per NCTE Regulations, 2014, which is not in the NCTE prescribed proforma.

(ii) Total land area and built up area not mentioned in the building plan.

(iii) Building completion certificate is not in the NCTE prescribed proforma.

- (iv) Photocopy of two FDRs of Rs. 5 lake and Rs. 11 lake are in single mode ie.e in the name of the institution only instead of jointly operation mode with RD, ERC, NCTE, Bhubaneswar.
- 3. **AND WHEREAS**, in response to SCN issued to the institution dated 28.11.2018 reply of SCN not received in this office within stipulated time. Matter placed in the 274th ERC meeting held on 15th 16th July 2019 and committee decided and observed as under:
  - > 1st show cause notice u/s 17(1) issued on 20.04.2018, followed by final show cause notice dated 28.11.2018 on the following grounds
    - a) Faculty list comprising 10 instead of 16 as per NCTE Regulations, 2014, which is not in the NCTE prescribed proforma.

b) Total land area and built up area not mentioned in the building plan.

c) Building completion certificate is not in the NCTE prescribed proforma.

d) Photocopy of two FDRs of Rs.5 lakh and Rs.11 lakh are in single mode i.e. in the name of institution only instead of jointly operation mode with RD, ERC, NCTE, Bhubaneswar.

No reply received and the stipulated time period has already been over

Recognition granted to **B.Ed. course** is **withdrawn** under section 17(1) of NCTE Act, 1993 from the academic session 2020-2021.
