ORDER

WHEREAS, Digboi B.Ed. College, C/o-The Little Stars School, Borbil No. 1, Digboi, Tinsukia, Assam-786171 (APE00341) was granted recognition for B.Ed, course with an intake of 100 vide ERC's Order No. 88-96 dated 07.09.2005, followed by revised recognition order vide No. 32107 dated 26.05.2015 with an intake of 100 from the academic session 2015-2016 as per NCTE Regulations, 2014 subject to fulfilment of the conditions in respect of enhancement of additional built up area, additional infrastructure, additional fund, additional staff, maintain and update website and to comply the same to the ERC.

2. AND WHEREAS, the ERC in its 254th Meeting held on 16th - 17th April, 2018 considered the matter and Show Cause Notice u/s 17(1) was issued on 20.04.2018 to the institution.

3. AND WHEREAS, the institution has submitted reply dated 05.05.2018 in response to SCN, which was considered by ERC in its 261st Meeting held on 24th - 25th September, 2018 and Show Cause Notice u/s 17(1) was issued on 08.10.2018 to the institution on the following grounds:-

- (i) Submitted faculty list is of 11 numbers instead of 16.
- (ii) Building plan and building completion certificate duly approved by Govt. Engineer not submitted.

4. AND WHEREAS, the institution has submitted reply dated 29.10.2018 received in this office on 06.11.2018. The ERC in its 279th Meeting held on 14th - 16th February, 2020 considered the original file of the institution along with other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time, were carefully considered by ERC and the following observation was made:-

- (i) Approved latest faculty list duly approved by the concerned affiliating body has not submitted.
- (ii) Requisite information of the institutional website has not updated as per clause 7(14)(i) of the NCTE Regulation, 2014.

Hence, B.Ed. course is withdrawn under section 17(1) of NCTE Act, 1993 from the next academic session 2020-21.




