#### **ORDER**

WHEREAS, Kaliabor College of Education, P.O.-Kuwaritol, Dist. Nagaon, Assam-782137 (B.Ed.) (APE00454) was granted recognition for B.Ed. course with an intake of 100 vide ERC's Order No. 4964 dated 15.12.2006, followed by revised recognition order vide No. 31825 dated 22.05.2015 with an intake of 100 from the academic session 2015-2016 as per NCTE Regulations, 2014 subject to fulfilment of the conditions in respect of enhancement of additional built up area, additional infrastructure, additional fund, additional staff, maintain and update website and to comply the same to the ERC.

- 2. **AND WHEREAS**, the ERC in its 254<sup>th</sup> Meeting held on 16<sup>th</sup> 17<sup>th</sup> April, 2018 considered the matter and Show Cause Notice u/s 17(1) was issued on 20.04.2018 to the institution.
- 3. **AND WHEREAS,** the institution has submitted reply dated 05.05.2018 in response to SCN, which was considered by ERC in its 274<sup>th</sup> Meeting held on 15<sup>th</sup> 16<sup>th</sup> July, 2019 and Final Show Cause Notice u/s 17(1) was issued on 22.08.2019 to the institution on the following grounds:-
  - (i) Faculty list comprises 1+13 instead of 1+15 as per NCTE Regulations, 2014.

(ii) FDRs are not in joint mode.

- (iii) Fire safety certificate is not submitted.
- (iv) Website not updated.
- 4. **AND WHEREAS**, the institution has submitted reply dated 26.08.2019 received in this office on 28.08.2019. The ERC in its 279<sup>th</sup> Meeting held on 14<sup>th</sup> 16<sup>th</sup> February, 2020 considered the original file of the institution along with other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time, were carefully considered by ERC and the following observation was made:-

(i) Built up area is less as prescribed in regulation 2014.

(ii) List of teaching faculty namely at. Dr. Minati Sarmah Bharati & Mrs. Minaksh Borah are not qualified as per NCTE Regulation, 2014.

Hence, B.Ed. course is withdrawn under section 17(1) of NCTE Act, 1993 from the next academic session 2020-21.
