ORDER

WHEREAS, College of Education, Christian Basti, Amarawati Path, P.O.-Dispur, Guwahati, Assam –781005 (Code No. AS-S/E-12/96) was granted recognition for B.Ed. course with an intake of 60 from the academic session 1998-1999 vide ERC order dated 06.03.1998 and continued time to time. Permission was granted for additional intake of 40, thus total intake of 100 from the academic session 2005-2006 vide order dated 21.07.2005, followed by revised order vide No.31850 dated 22.05.2015 from the academic session 2015-2016 as per NCTE Regulations, 2014 subject to fulfilment of the conditions in respect of enhancement of additional built up area, additional infrastructure, additional fund, additional staff, maintain and update website and to comply the same to the ERC.

- 2. **AND WHEREAS**, the ERC in its 272^{nd} meeting held on $30^{th} 31^{st}$ May & 1^{st} June, 2019 considered the matter along with reply vide letters dated 14.05.2019 & 16.05.2019 (on the basis of proceedings uploaded on ERC website) submitted by the institution in response to Show Cause Notice and observed as under:
 - (i) Show Cause Notice u/s 17(1) were issued on 20.04.2018, 14.12.2018, 21.02.2019 & 16.05.2019.

(ii) Principal does not possess Ph.D. qualification.

(iii) Faculty in Fine Arts appointed on part-time basis is not accepted.

(iv) FDR Rs.5 lakh is not in joint mode with RD, ERC, NCTE.

(v) Building completion certificate is not submitted.

In view of the above, the Committee decided as under:

The Committee is of the opinion that recognition granted to B.Ed. course of the application bearing Code No. AS-S/E-12/96 is withdrawn under section 17(1) of NCTE Act, 1993 from the academic session 2019-2020.

3. **AND WHEREAS**, the order of withdrawal was not issued to the institution and the matter was re-considered by the ERC in its 273rd Meeting held on 14th June, 2019 and observed that in terms of Section 17(1) of NCTE Act, 1993, order withdrawing or refusing recognition passed by the Regional Committee shall come into force only with effect from the end of the academic session next following the date of communication of such order. In the instant cases, all formalities and process of counselling for admission of students have been completed by the affiliating/examining bodies for the next academic session 2019-2020.

In view of the above, the Committee decided as under:

Recognition to **B.Ed. course** be **withdrawn** from the academic session **2020-2021** instead of **2019-2020** in all respect and orders be issued accordingly.

- 4. NOW THEREFORE, recognition granted to the institution viz. College of Education, Christian Basti, Amarawati Path, P.O.-Dispur, Guwahati, Assam –781005 (Code No. AS-S/E-12/96) for B.Ed. Course is hereby withdrawn under section 17(1) of NCTE Act, 1993 from the academic session 2020-2021.
- 5. **FURTHER**, if the institution is not satisfied by the order, they can prefer an appeal Under Section 18 of the NCTE Act in the "Online mode" available on NCTE's website www.ncte-india.org within 60 days from the date of the issue of the order.
