Order

In terms of Section 14(1) of the NCTE Act, 1993 Bongaigaon B.Ed. College, PO/Dist. Bongaigaon, Assam, Pin - 783 380 had submitted an application to the Eastern Regional Committee of NCTE for grant of recognition for starting B.Ed. Course of one year duration from the academic session 2002-2003.

- On scrutiny of the application submitted by the institution, the documents 2. attached therewith, the inputs received from the visiting team and replies dated 18.9.2004 and 23.9.2004 received from the institution in response to clarifications on show cause notice dated 12.7.2004 issued on the basis of deficiencies observed in the visiting team report, the Committee has noted the following:
 - The institution has acquired the land for setting up the teacher education institution.
 - The institution has constructed the building for conducting the course ii) on the above mentioned land.
 - The institution has created an Endowment Fund of Rs.5.00 lakhs and iii) Reserve Fund of Rs.38,000/-
 - The institution has selected the Principal and 6 (six) teachers for the iv) said course and the list of faculty members has also been approved by the affiliating University i.e. Registrar, Gauhati University.
- 3. Now, therefore, in exercise of the powers vested under Section 14(3) (a) of the NCTE Act, 1993, the Regional Committee hereby grants recognition to Bongaigaon B.Ed. College, PO/Dist. Bongaigaon, Assam, Pin - 783 380 for B.Ed. Course of one year duration from the academic session 2004-2005 with an annual intake of 100 (one hundred) students subject to fulfillment of the following:
 - That the institution shall appoint one more qualified teacher as per NCTE a) / norms immediately and a report to this effect shall be sent to the Eastern Regional Committee before the commencement of the course.
 - The institution will ensure that Principal and at least 7 (seven) faculty b) members duly approved by the affiliating University are in position for an intake of 100 students before the commencement of the course and a report to this effect shall be sent to the Eastern Regional Committee.
 - The institution shall, within one month of the receipt of recognition order, c) convert the endowment fund account into a joint account to be operated along with an official of the Eastern Regional Committee.
 - The institution shall maintain reserve fund equivalent to three months' d) salary of the staff as per NCTE norms and a report to this effect shall be sent to the Eastern Regional Committee before the commencement of
 - The institution shall comply with the various other norms and standards e) prescribed in the NCTE regulations.

- **4.** Further, the recognition is subject to fulfillment of all such other requirements as may be prescribed by other regulatory bodies like UGC, the State Government etc.
- 5. The institution shall submit to the Regional Committee a Performance Appraisal Report at the end of each academic year along with a copy of the approval of the affiliating University to the appointment of faculty members, and the statement of annual accounts duly audited by a Chartered Accountant.
- **6.** If the institution contravenes any of the above conditions or any of the provisions of the NCTE Act, Rules, Regulations and Orders made or issued thereunder, the Regional Committee may withdraw the recognition under the provisions of Section 17(1) of the NCTE Act.
