**ORDER**

In exercise of the authority vested under NCTE Act, the Eastern Regional Committee after considering the application of **Bongaigaon B.Ed. College (Assam)** for grant of recognition to the **B.Ed. Course** of one year duration, has decided to extend provisional recognition for one year with effect from the academic year 2000-2001 with intake of **60(sixty)** students subject to removal of the following deficiencies :

- (i) The qualifications of the teaching staff should be as per NCTE norms.
- (ii) The teachers should be paid salary as per UGC/State Govt. scale.
- (iii) The curriculum transaction should be as per NCTE norms.
- (iv) Furniture and equipment should be augmented as per NCTE norms.
- (v) Books and journals in the library should be provided as per NCTE norms.
- (vi) Science and Social Science labs are developed as per NCTE norms.
- (vii) Hostel for the students and staff-quarters should be constructed.
- (viii) Students with 45% marks in the qualifying examination should be admitted.
- (ix) Curriculum transaction should be as per NCTE norms.

The institution concerned is advised to send a compliance report about removal of above deficiencies to the Eastern Regional Committee by 31.8.2000.
