WHEREAS, College of Teacher Education, Mangaldai (Formerly: Mangaldai Teachers' Training College), Darrang, Assam-784125 (File No. AS-S/E-3/97) was granted recognition for B.Ed. course with an intake of 60 from the academic session 2001-2002 vide ERC Order No. 1502 dated 23.05.2001, followed by revised order vide No.32142 dated 26.05.2015—with—an intake of 50 from the academic session 2015-2016 as per NCTE Regulations, 2014 subject to fulfilment of the conditions in respect of enhancement of additional built up area, additional infrastructure, additional fund, additional staff, maintain and update website and to comply the same to the ERC.

- 2. AND WHEREAS, the ERC in its 274th Meeting held on 15th -16th July, 2019 considered the matter along with the reply dated 20/05/2019 submitted by the institution in response to Show Cause Notice and observed as under:
 - (i) 1st show cause notice u/s 17(1) issued on 21.02.2019, followed by final show cause notice dated 18.05.2019 to comply the following:
 - a) Approved faculty list by the concerned affiliating body along with requisite documents.
 - b) Approved building plan by the concerned competent Govt. Engineer/Authority.
 - c) Approved building completion certificate by the concerned competent Govt. Engineer/Authority.
 - d) FDRs towards Endowment fund and Reserve fund after conversion into joint operation mode as prescribed in the NCTE Regulations, 2014.
 - e) Confirmation on website updates of the institutions with all details along with affidavit.

In view of the above, the Committee decided as under:

Recognition granted to **B.Ed. course** is **withdrawn** under section 17(1) of NCTE Act, 1993 from the academic session 2020-2021.

4. NOW THEREFORE, recognition granted to the institution viz. College of Teacher Education, Mangaldai (Formerly: Mangaldai Teachers' Training College), Darrang, Assam-784125 (File No. AS-S/E-3/97) for B.Ed. Course is hereby withdrawn under section 17(1) of NCTE Act, 1993 with effect from the academic session 2020-2021.
