ORDER

WHEREAS, Dhemaji Post Graduate Training College, Dhemaji, Assam-787057 (ERCAPP1123) was granted recognition for B.Ed. course with an intake of 60 from the academic session 2014-2015 vide ERC Order No. 1554 dated 11.08.2003, followed by revised order vide No. 31872 dated 23.05.2015 with an intake of 50 from the academic session 2015-2016 as per NCTE Regulations, 2014 subject to fulfilment of the conditions in respect of enhancement of additional built up area, additional infrastructure, additional fund, additional staff, maintain and update website and to comply the same to the ERC.

2. **AND WHEREAS**, the ERC in its 271st meeting held on 24th - 25th April, 2019 considered the matter and as decided, Show Cause Notice u/s 17(1) was issued on 16.05.2019 to the institution on the following grounds:

- (i) The submitted building completion certificate is not in accordance with NCTE prescribed proforma indicating total land area and built up area etc. and not approved by competent Govt. Engineer.
- (ii) Photocopy of FDRs are not in joint mode.
- (iii) Faculties as per submitted list are 06 (Regular) only. However, 08 (Ad-hoc) and 02 (Guest) lecturers appointed are not accepted as per NCTE Regulations, 2014.
- (iv) Total land area and built up area not mentioned in the submitted building plan.

3. **AND WHEREAS**, the matter was placed before the committee in its 274th ERC meeting held on 15th - 16th July, 2019 considered the matter along with the reply dtd. 17.06.2019 submitted by the institution in response to the SCN dtd. 16.05.2019 and observed as under:

- 1st show cause notice u/s 17(1) issued on 21.02.2019, followed by final show cause notice dated 16.05.2019 and the institution is still deficient on the following grounds:


- (i) Faculty list is not as per NCTE Regulations, 2014.
- (ii) Part-time/guest faculty are not accepted

4. **NOW THEREFORE**, recognition granted to the institution viz. Dhemaji Post Graduate Training College, Dhemaji, Assam-787057 (File No. As-S/E-7/96) for B.Ed. Course is hereby **withdrawn** under section 17(1) of NCTE Act, 1993 from the academic session 2020-2021.


