ORDER

WHEREAS the appeal of Lakhimpur P.G. Training College, Lakhimpur, Assam dated the 23/08/2004 is against the Order No. ERC/7-46(ER-46.6.3)/2004/2044 dated the 09/07/2004 of the Eastern Regional Committee. Withdrawing recognition for conducting B.Ed. course on the grounds that 1) Out of the requirement of Principal and 07 lecturers, 03 lecturers are not qualified as per NCTE norms. 2) Tuition fee is not charged as per University/State Govt. fee structure but is being paid as per the decision of the Governing Body. 3) There is shortage in Practice teaching as per NCTE norms.


AND WHEREAS the Correspondent, Lakhimpur P.G. Training College (hereinafter referred to as the appellant), preferred an appeal dated the 23/08/2004 to the National Council for Teacher Education, New Delhi (hereinafter referred to as the Council) under Section 18 of the NCTE Act, 1993 against the said Order.

AND WHEREAS Smt. Rekha Phukan, Principal, Lakhimpur P.G. Training College, Lakhimpur, Assam presented the case of the appellant institution on 29/09/2004. In the appeal and during personal presentation it was submitted that all the teachers are properly qualified and the Practice teaching is as per NCTE regulations. As regard tuition fee it was submitted that the State Govt has not prescribed any fee structure and therefore the fee is being charged as per decision of the Governing Body.

AND WHEREAS the Council had asked the institution to submit two documents, approved list of teaching staff by Dibrugarh University and a certificate that the State Govt has not prescribed any fee structure for Govt. un-aided colleges, before the decision on the appeal could be taken.

AND WHEREAS the desired documents were received from the institute on 22-06-2005 and were placed before the Council Meeting held on 13-07-2005. The Council, on perusal of these documents and the presentation and submission made on 29/09/2004 decided to reverse the Order dated 9/07/2004 of ERC, Bhubaneswar.

AND NOW THEREFORE, the Council hereby reverses the Order appealed against.
