Order

WHEREAS in terms of Section 14(1) of the NCTE Act, 1993 Dhubri Post Graduate Teacher Training College, Bidyapara, PO: Bidyapara, Dist-Dhubri, Assam - 783324 had submitted an application to the Eastern Regional Committee of NCTE for grant of recognition for starting B.Ed. Course of one year duration with an annual intake of 100 (one hundred) students.

2. AND WHEREAS the applicant institution was granted recognition for B.Ed. Course of one duration by ERC NCTE from the academic session 2002-2003 with an annual intake of 100 students under Section 14 of NCTE Act, vide order No.ERC/7-26/2002/2107 dt.19.07.2002.

3. AND WHEREAS the Eastern Regional Committee in its 44th meeting held on 30.04.2004 considered the Performance Appraisal Report 2002-2003 of the applicant institution and asked clarification vide letter No. ERC/7-44 (ER-44.8(b).4)/2004/1562 dt.14.05.2004

6. AND WHEREAS the Eastern Regional Committee held on 30.11.2004 considered the reply dt.04.11.2004 from the institution as well as documents and materials submitted by the institution and withdrawn recognition of B.Ed. course under Section 17(1) of the NCTE Act vide order No.ERC/7-51(ER-51.7.5)2004 / 3606 dt.09.12.2004 on the ground that the institution paying consolidated salary to the teachers where as the latest NCTE norms for Secondary Teacher Education Programme provides the academic and other staff of the institution including part-time staff shall be paid such salary as may be prescribed by the concerned State Govt. / University from time to time.

7. AND WHEREAS the applicant institution preferred an appeal dt.01.02.2005 to the Council under Section -18 of the NCTE Act, 1993 against the said order.

8. AND WHEREAS the Council took note of the submissions as above and also the fact that no other irregularities has been found in implementation of the course by the college and reversed the ERC order of withdrawal of recognition dated 9.12.2004 vide its Order F.No.89/29/2005-Appeal dt.09.06.2005.

9. AND WHEREAS the Eastern Regional Committee in its 58th meeting held on 6.7.2005 noted the order of reversal of recognition issued by the Council.

10. AND WHEREAS the Eastern Regional Committee in its 75th meeting held on 10-11 April, 2007 noted the decision taken in the 73rd ERC meeting and decided to issue the orders as per direction of NCTE in respect of the concerned institutions.

11. NOW, THEREFORE, in exercise of the powers vested under Section 14(3) (a) of the NCTE Act, 1993, the Eastern Regional Committee hereby grants recognition to Dhubri Post Graduate Teacher Training College, Bidyapara, P.O: Bidyapara, Dist-Dhubri, Assam - 783324 for conducting B.Ed. Course of one year duration with an annual intake of 100 (one hundred) students under clause 7(10) of Regulation dated 13-1-2006 subject to fulfillment of the following:

(i) The institution shall comply with the various other norms and standards prescribed in the NCTE regulations, as amended from time to time.

12. Further, the recognition is subject to fulfillment of all such other requirements as may be prescribed by other regulatory bodies like UGC and State Government etc. wherever applicable.

13. The institution shall submit the Eastern Regional Committee a Self-Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant together with statement of T.D.S. in respect of the salary paid to the staff.

14. If the institution contravenes any of the above conditions or any of the provisions of the NCTE Act, Rules Regulations and Orders made or issued thereunder, the Eastern Regional Committee may withdraw the recognition under the provisions of Section 17(1) of the NCTE Act.
