Order

In exercise of the authority vested under NCTE Act, the Eastern Regional Committee after considering the application of **Dhubri Post-Graduate Teacher Training College, P.O./Dist. Dhubri-783 301 (Assam)** for grant of recognition to the **B.Ed.** course of one year duration, decided to extend one year conditional recognition for the academic year 2000-2001 with intake of 60 subject to removal of the following deficiencies :

- ✓1. The Principal qualified as per NCTE norm is appointed and reported to ERC by 30.6.2000.
- ✓2. Six full-time qualified teaching staff should be in position by 30.6.2000.
3. The teachers should be paid as per UGC/State Govt. scales.
4. Library should be enriched as per NCTE norm.
5. Multipurpose Lab. with equipment should be developed as per NCTE norms.
6. The students with 45% marks in Graduation/Post Graduation are admitted for the said course.
7. Furniture and other equipment should be as per NCTE norm.
8. The building should be constructed as per NCTE norms.
9. Curriculum transaction should be as per NCTE norms.
10. Supervised Practice Teaching should be conducted as per NCTE norms.
11. Reserve fund and Endowment fund should be maintained as per NCTE norms.
12. The institution should obtain affiliation from the university.

The institution is advised to send a compliance report about removal of the above deficiencies to the Eastern Regional Committee by 31.8.2000.
