WHEREAS, Barnagar B.Ed. College, Sorbhog, Barpeta, Assam-781317 (AS-S/N-6/2000) was granted recognition for B.Ed. course with an intake of 50 from the academic session 2001-2002 vide ERC's Order No. 1659 dated 15.06.2001, followed by revised recognition order vide No. 31924 dated 23.05.2015 with an intake of 50 from the academic session 2015-2016 as per NCTE Regulations, 2014 subject to fulfilment of the conditions in respect of enhancement of additional built up area, additional infrastructure, additional fund, additional staff, maintain and update website and to comply the same to the ERC.

- AND WHEREAS, the ERC in its 267th Meeting held on 10th 11th February, 2019 considered the matter and Show Cause Notice u/s 17(1) was issued on 21.02.2019 to the institution.
- AND WHEREAS, the institution has submitted reply dated 29.03.2019 in response to 3. SCN, which was considered by ERC in its 275th Meeting held on 27th July, 2019 and Final Show Cause Notice u/s 17(1) was issued on 02.09.2019 to the institution on the following grounds:-

Faculty list is not approved by concerned affiliating body.

- Blue print building plan duly approved by competent Govt. Engineer is not (ii) submitted.
- (iii) Building completion certificate is not submitted in the NCTE prescribed proforma duly approved by competent Govt. Engineer.

(iv) FDRs Rs.5 lakh and Rs.7 lakh in joint mode are not submitted.

- (v) Website not maintained and updated.
- AND WHEREAS, the institution has submitted reply dated 21.09.2019 received in this office on 15.10.2019. The ERC in its 279th Meeting held on 14th - 16th February, 2020 considered the original file of the institution along with other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time, were carefully considered by ERC and the following observation was made:-
 - Total land area & built up area is not mentioned in the Building Plan (BP).

Building Completion Certificate (BCC) is not in the prescribed proforma and the total built up area is not mentioned in the BCC.

(iii) Requisite information of the institutional website has not update as per clause 7(14)(i) of the NCTE Regulation, 2014.

Hence, B.Ed. course is withdrawn under section 17(1) of NCTE Act, 1993 from the next academic session 2020-21.
