WHEREAS, Reimalie Academy College, Plot No. 511, Vill. - Bhatipara Revenue, Bijni, PO. - Bijni, Tehsil/Taluka - Bijni, Town/Ci.y-Bijni, DistBongalgaon, Assam-783390 (ERCAPP1350) was granted recognition for B.Ed. course with an intake of 100 from the academic session 2014-2015 vide ERC Order No. 24325 dated 03.03.2014, followed by revised order vide No. 31767 dated 20.05.2015 from the academic session 2015-2016 as per NCTE Regulations, 2014 subject to fulfilment of the conditions in respect of enhancement of additional built up area; additional infrastructure, additional fund, additional staff, maintain and update website and to comply the same to the ERC.

- 2. AND WHEREAS, the ERC in its 27.1st meeting held on 24th 25th April, 2019 considered the matter and as decided, Show Cause Notice u/s 17(1) was issued on 18.05.2019 to the institution on the following grounds:
 - (i) Validity of submitted FDRs expired, need to be renewed
 - (ii) Website not maintained and updated.
- 3. AND WHEREAS, the matter was placed before the committee in its 275th ERC meeting held on 27th July, 2019 considered the matter and reply dtd. 01.07.2019 submitted by the institution in response to the SCN dtd. 18.05.2019 and committee took the decision as under:
 - > 1st show cause notice u/s 17(1) issued on 22.02.2019, followed by final show cause notice dated 18.05.2019 and the institution is still deficient on the following grounds:-

(i) Faculty list is not appropriate as per NCTE Regulations, 2014.

- (ii) Faculties at sl. No.6, 7, 8, 9, 10, 11 & 12 appointed after 09.06.2017 for Pedagogy subjects do not have NET/Ph.D. qualification as per Gazette Notification No.237 of NCTE published on 09.06.2017.
- (iii) Renewed FDRs in joint mode are not submitted.
- 4. NOW THEREFORE, recognition granted to the institution viz. Reimalie Academy College, Plot No. 511, Vill.- Bhatipara Revenue, Bijni, PO.- Bijni, Tehsil/Taluka- Bijni, Town/City-Bijni, DistBongaigaon, Assam-783390 (ERCAPP1350) for B.Ed. Course is hereby withdrawn under section 17(1) of NCTE Act, 1993 from the academic session 2020-2021.
