**ORDER**

WHEREAS, Reimalie Academy College, Vill.- Bhatipara Revenue, Tehsil/Taluka- Bijni, Town/City- Bijni, P.O.- Bijni, Dist.- Bongaigaon, Assam- 783390 (Code No. ERCAPP1350) was granted recognition vide ERC (NCTE) order dated 03.03.2014 for conducting B.Ed. Course of one year duration with an annual intake of 100 students from the academic session 2014-2015.

2. AND WHEREAS, Revised Recognition Order (RRO) was issued to the institution on 20.05.2015 for conducting B.Ed. course of two years duration with an annual intake of 100 students from the academic session 2015-2016 as per NCTE Regulations, 2014 subject to fulfilment of the conditions in respect of enhancement of additional built up area, additional infrastructure, additional fund, additional staff, maintain and update website and to comply the same to the ERC.

3. AND WHEREAS, the ERC in its 275<sup>th</sup> (Part-1) meeting held 26<sup>th</sup> July, 2019 considered the matter and as decided, recognition to B.Ed. Course was withdrawn u/s 17(1) vide order No. 61387 dated 26.08.2019 from the academic session 2020-2021 on the following grounds:-


- (i) Faculty list is not appropriate as per NCTE Regulations, 2014.
- (ii) Faculties at sl. No.6, 7, 8, 9, 10, 11 & 12 appointed after 09.06.2017 for Pedagogy subjects do not have NET/Ph.D. qualification as per Gazette Notification No.237 of NCTE published on 09.06.2017.
- (iii) Renewed FDRs in joint mode are not submitted.

4. AND WHEREAS, the institution preferred an appeal to the NCTE Hqrs. against the ERC's order dated 27.06.2019. The Appellate Authority vide its Order No.89-371/E-135959/2019 Appeal/34<sup>th</sup> Mtg.-2019/22<sup>nd</sup> November, 2019/85854 dated 05.12.2019 remanded back the case to ERC for revisiting the matter after the appellant institution submits to ERC within 15 days of issue of appeal order the List of faculty approved by Bodoland University on 04/09/2019 and the FDRs in joint mode.

5. AND WHEREAS, the institution submitted reply vide letter dated 16.12.2019 received in this office on 19.12.2019. The ERC in its 279<sup>th</sup> meeting held on 14<sup>th</sup> – 16<sup>th</sup> February, 2020 considered the original file of the institution alongwith other related documents, NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time and appeal order dated 05.12.2019 and decided as under:-




