Order

In terms of Section 14(1) of the NCTE Act, 1993 DIET, Sivasagar, Po- Bhojo Subdivision:- Charaideo, Sonari, Dist- Sivasagar Assam – 785691 had submitted an application to the Eastern Regional Committee of NCTE for grant of recognition for starting P.S.T.E. (Elementary) course of two years duration from the academic session 2004-2005.

2. On scrutiny of the application submitted by the institution, the documents attached therewith, the inputs received from the visiting team alongwith, other related documents, the Committee has noted the following:

- i. The institution has acquired the land for setting up the teacher education institution.
- ii. The institution proposes to function from its own building.
- iii. The institution has selected the Principal-in-charge and 07 (seven) faculty members for the said course and the list of faculty members has not been duly approved by the competent authority of affiliating body.

3. Now, therefore, in exercise of the powers vested under Section 14(3) (a) of the NCTE Act, 1993, the Regional Committee hereby grants recognition to DIET, Sivasagar, Po- Bhojo Subdivision:- Charaideo, Sonari, Dist- Sivasagar Assam – 785691 for **PSTE (Elementary) Course of two years duration from the academic session 2006-2007 with an annual intake of 50 (fifty) students** subject to compliance of the following conditions before the commencement of the course:

- a) The institution will ensure that Principal and at least 05 (five) faculty members duly qualified as per NCTE norms are in position for an intake of 50 students before the commencement of the course and a report to this effect shall be sent to the Eastern Regional Committee within one month of the commencement of the course.
- b) The institution shall submit a list of teaching staff duly countersigned by the competent authority of the affiliating body within one month of the commencement of the course.
- c) The institution shall pay salary to the teaching staff as prescribed by State Govt.
- d) The institution shall adhere to all the other regulations and guidelines as framed by NCTE from time to time.



4. Further, the recognition is subject to fulfillment of all such other requirements as may be prescribed by other regulatory bodies like UGC, the State Government etc.

5. The institution shall submit to the Regional Committee a Performance Appraisal Report at the end of each academic year along with a copy of the approval of the affiliating body to the appointment of faculty members, and the statement of annual accounts duly audited by a Chartered Accountant.

6. If the institution contravenes any of the above conditions or any of the provisions of the NCTE Act, Rules, Regulations and Orders made or issued there under, the Regional Committee may withdraw the recognition under the provisions of Section 17(1) of the NCTE Act.
