- 1. The institution shall comply with the various other norms and standards prescribed in the NCTE regulations, as amended from time to time.

 - h) Number of books in the library, journals subscribed to, and additions, if any, in the last quarter;
 - i) The affidavit with enclosure submitted along with application;
 - j) The institution shall be free to post additional relevant information, If it so desires.
 - k) Any false or incomplete information on its website shall render the institution liable for withdrawal of recognation.
