WHEREAS, Department of Education, Assam University, Silchar, Assam - 788011 (Code No. APE00523) was granted recognition for M.Ed. course with an intake of 25 from the academic session 2007-2008 vide ERC Order No. 6229 dated 09.02.2007, followed by revised order vide No. 32647 dated 31.05.2015 from the academic session 2015-2016 as per NCTE Regulations, 2014 subject to fulfilment of the conditions in respect of enhancement of additional built up area, additional infrastructure, additional fund, additional staff, maintain and update website and to comply the same to the ERC.

2. **AND WHEREAS**, the ERC in its 271<sup>st</sup> meeting held on 24<sup>th</sup> - 25<sup>th</sup> April, 2019 considered the matter and as decided, Show Cause Notice u/s 17(1) was issued on 18.05.2019 to the institution on the following grounds:

- (i) Approved faculty list (current) by the concerned affiliating body along with requisite documents.
- (ii) Approved building plan by the concerned competent Govt. Engineer/Authority.
- (iii) Approved building completion certificate by the concerned competent Govt. Engineer/ Authority.
- (iv) FDRs towards Endowment fund and Reserve fund after conversion into joint operation mode as prescribed in the NCTE Regulations, 2014.
- (v) Confirmation on website updates of the institutions with all details along with affidavit.

3. **AND WHEREAS**, the ERC in its 278<sup>th</sup> Meeting held on 16<sup>th</sup> - 18<sup>th</sup> January, 2020 for non-compliance of SCN Issued previously on 18.05.2019 and committee took decision as under:

- a) Two show cause notices issued on 14.02.2019 & 18.05.2019 and no reply has been received till date.

**In view of the above, the Committee decided as under:**

Hence, M.Ed. Course is withdrawn under section 17(1) of NCTE Act, 1993 from the next academic session 2020-2021.




