WHEREAS, Govt. Teacher's Training College, Turki, Muzaffarpur, Bihar-844127 (APE00324) was granted recognition for B.Ed. course with an intake of 100 from the academic session 2006-2007 vide ERC Order No. 2236-2242 dated 05.01.2006, followed by revised order vide No.32386 dated 29.05.2015 with an intake of 100 from the academic session 2015-2016 as per NCTE Regulations, 2014 subject to fulfilment of the conditions in respect of enhancement of additional built up area, additional infrastructure, additional fund, additional staff, maintain and update website and to comply the same to the ERC.—

- 2. **AND WHEREAS**, the ERC in its 271st meeting held on 24^{th} 25^{th} April, 2019 considered the matter and as decided, Show Cause Notice u/s 1.7(1) was issued on 18.06.2019 to the institution on the following grounds:
 - (i) The submitted faculty list is not in accordance with NCTE Regulations, 2014 and Gazette Notification No.237 of NCTE published on 09.06.2017. Part-time faculties are not accepted.
- 3. **AND WHEREAS**, the ERC in its 275th Meeting held on 27th July, 2019 considered the matter and reply dated 03.07.2019 from the institution in response to Show Cause Notice. dated 18.06.2019 and observed as under.
 - 1st show cause notice u/s 17(1) issued on 17.05.2018. Final show cause notice issued dated 18.06.2019 and the institution is still deficient on the following ground:-
 - (i) No reply of SCN dated 18.06.2019 received from the institution only a letter dated 03.07.2019 from Govt. of Bihar without supporting documents.
 - (ii) Submitted faculty list is not in accordance with NCTE Regulations, 2014 and Gazette Notification No.237 of NCTE published on 09.06.2017. Part-time faculties are not accepted.

Recognition granted to B.Ed. course is withdrawn under section 17(1) of NCTE Act, 1993 from the academic session 2020-2021.

4. NOW THEREFORE, recognition granted to the institution viz. Govt. Teacher's Training College, Turki, Muzaffarpur, Bihar-844127 (Code No. APE00324) for B.Ed. Course is hereby withdrawn under section 17(1) of NCTE Act, 1993 from the academic session 2020-2021.
